- 8 Between 2007-2010, Andrew was Director of Mediation Training for the Royal Institution of Chartered Surveyors and led the CMC approved RICS mediator training courses in the UK and abroad until 2013.
- 9 Andrew leads the regular 5-day SCMA mediator training courses (CMC registered) for barristers' chambers and the Wales & Chester Circuit of the Bar, and in house and open training in Amsterdam, Dubai, Kuala Lumpur, Lagos, Istanbul, Ankara, Abu Dhabi, Oman and Kuwait for lawyers and construction industry professionals.
- 10 He is lead trainer for ADR Group in both Civil/Commercial and Workplace mediation, conducting courses live and online.
