The Monthly Fees EXCLUDE tote bags, nap mats, field trips, graduation fees, seasonal events and yearbooks. Lunch and other incidental fees are billed separately. All Tuition and Fees are billed through FACTS and only ACH and credit card arrangements are available. An early pay incentive is offered.
- Families with two or more students** attending Elementary or Middle School who do not qualify for an EITC Scholarship will receive reduced tuition rates as reflected above via the Msgr. Burke Scholarship program. Fundraising activities throughout the year help to replenish this important program. Please participate as best you are able.

Welcome Grants

A Welcome Grant of \$500 will be extended to EVERY student attending Kindergarten for the 2025-2026 school year.

Almost \$85,000 in Welcome Grants have been awarded to our school families over the past 3 years!

Family Loyalty Grants

New for the 2025-2026 School Year, all PK students (PK3 and PK4) will receive a \$500 grant if they have an older sibling enrolled and attending Grades K through 8 at SSPJ.

Tuition Reduction Grants

Because SSPJ school families and parishioners voluntarily choose to participate in the **Foundation for Catholic Education's TuitionCare** program, a Tuition Reduction Grant (TRG) will be extended automatically in early 2026 to ALL families with students attending Elementary and Middle Schools.

Ask how you can redirect some of your PA Income Taxes to help offset tuition for ALL K-8 grade families who choose to send their students to Catholic schools.

Our families have received Tuition Reduction Grants which total nearly \$300,000, saving over \$3,00 per family, in just the first four years of participation!

Educational Improvement Tax Credits (EITC) Scholarships

Pennsylvania provides tax credits for corporate contributions to nonprofit organizations that provide private school scholarships. Students are eligible for financial scholarships if their family's household incomes falls below a certain threshold. Each year SSPJ utilizes these available funds to provide tuition assistance in the form of scholarships to eligible students. Further details and an application to apply for an EITC scholarship is available on the school's website. (\$35 FACTS application fee)

Since 2021 we have awarded ~ \$600,000 in EITC scholarships to eligible students who otherwise may not have been able to afford a Catholic education!

Participating Stewardship of Church

SSPJ School relies on a substantial Parish subsidy to offer affordable Tuition and Fee rates to our school families. Through active participation in Stewardship of SS Philip and James Church, a family is eligible for these subsidized 'in parish' rates. Eligibility requires annual stewardship of Church contributions of \$20 per week or \$87 per month (\$1,040 annually) via ACH. **Church contributions are not included in tuition rates.** Please refer to the SSPJ Church Auto Debit Sunday Contributions enrollment form to participate in this program. All school families are expected to participate in this stewardship, otherwise 'out of parish' rates will apply.

Tuition Deposit (Non-Refundable)

Reenrolling student accounts will be invoiced automatically a \$200 deposit, per returning student, in the Spring 2026 via FACTS.

New students will be required to pay a \$200 non-refundable deposit at the time of registration.

The \$200 amount will be applied as a credit to the individual student accounts in FACTS during the first billing period of the new school year.

This enrollment / reenrollment deposit secures your student's seat for the following school year.

FACTS Fees

There is an annual \$10 reenrollment fee (per student) billed via FACTS for all returning students.

A Payment Plan Enrollment fee of \$47 is collected once a family selects which FACTS payment plan best suits their financial needs.

The Payment Plan Enrollment fee is waived if the family chooses to 'pay in full' or 'pay in 2 payments' via the FACTS payment plan system.

There is a \$50 non-refundable application fee (per student) administered via FACTS for all new applicants.
