## **OLD BUSINESS**

FINANCIALS AND RIDERSHIP: FOR THE FIRST 6 MONTHS OF THE FISCAL YEAR, 64% OF THE BUDGETED REVENUES HAVE BEEN RECEIVED AND 48% OF THE BUDGETS EXPENSES HAVE BEEN DISBURSED. MOTION BY PULLEN TO APPROVE TO TRANSFER \$25,000 FROM MACATAWA BANK TO A WEST MICHIGAN COMMUNITY BANK CD AND TO TRANSFER \$100,000 TO A NEW MONEY MARKET ACCOUNT AT PNC BANK. ROLL CALL VOTE: AYES: BABINSKI, JOHNSON, MUHA, MUNCEY, PULLEN, SCHNEIDER. NAY'S: NONE. MOTION CARRIED. RIDERSHIP HAS INCREASED BACK TO THE LEVEL CARRIED IN 2019. THE "ITA" CARRIED 3776 PASSENGERS!

## **B. CAPITAL GRANT PROGRESS:**

2019: THE \$11,000 BALANCE OF THE 2019 GRANT WILL BE USED TOWARDS THE PURCHASE OF THE 2020 GRANT FOR THE PROPANE BUS.

2020: DELIVERY OF THE THIRD PROPANE BUS MAY BE DELAYED UP TO ONE YEAR DUE TO SUPPLY CHAIN ISSUES AND LABOR SHORTAGES.

2021: APPROVAL HAS BEEN RECEIVED FROM MDOT TO PROCEED WITH THE "REQUEST FOR PROPOSAL" FOR THE TWO-WAY RADIOS. YFF SUBMITTED THE BUS CONVERSION "RFQ" TO MDOT FOR APPROVAL.
