OLD BUSINESS

A. FINANCIALS AND RIDERSHIP: DUE TO THE PANDEMIC, RIDERSHIP DECLINED 75% OVER JULY 2019. FINANCIALS REMAIN POSITIVE WITH A DECREASE IN EXPENDITURES. ACTUAL REVENUES AND EXPENSES ARE AT 97% AND 75% OF THE BUDGETED FIGURES. THE BOARD SUGGESTED KEEPING AN "ON CALL" DRIVER AVAILABLE EACH SATURDAY THROUGH SEPTEMBER TO SUPPORT INCREASED DEMAND. DISPATCHERS WERE ENCOURAGED TO CALL FOR "BACK UP" IF UNEXPECTED PEAKS OCCUR. YFF IS FOLLOWING UP TO SEE HOW MANY SCHOOL STUDENTS WILL BE TRANSPORTED THIS FALL.

B. OPEN GRANTS ARE AS FOLLOWS:

2019: TWO NEW PROPANE BUSES. PURCHASE HAS BEEN POSTPONED UNTIL FUTURE NEEDS ARE DETERMINED. 2020: \$20,0000 FOR NEW SHINGLES, AND A NEW PROPANE BUS OR VAN.

C. THE 40TH BIRTHDAY CELEBRATION HAS BEEN PUT ON HOLD AGAIN. YFF TO HOLD AN 'IN-HOUSE' EVENT WITH GIVEAWAYS TO PASSENGERS. THE OFFICIAL CELEBRATION MAY OCCUR NEXT YEAR WITH A "40+1" BIRTHDAY CELEBRATION!
