OLD BUSINESS

A. FINANCIALS AND RIDERSHIP: FOR THE FISCAL YEAR TO DATE, 77.1% OF THE BUDGETED REVENUES HAVE BEEN RECEIVED AND 75.3% OF THE BUDGETED EXPENSES HAVE BEEN DISBURSED. EXPENSES ARE 7.5% UP OVER THE PRIOR PERIOD. JULY RIDERSHIP INCREASED BY 1300 OVER JULY 2022. THE 'ITA' CARRIED 13,173 PASSENGERS!

B. CAPITAL GRANT PROGRESS:

2019: THE ITA WILL CONTINUE TO WAIT FOR THE PROPANE CUT AWAY BUS. THE ESTIMATED ARRIVAL IS EARLY 2024. 2021: 3 DISPATCH SOFTWARE DEMO'S HAVE BEEN REVIEWED TO FINALIZE THE RFP SPECIFICATIONS. YFF IS WORKING WITH MDOT'S PROCUREMENT SPECIALIST ON THE BUS CONVERSION GRANT. YFF IS WORKING WITH THE DOUGLAS CITY PLANNER TO REVIEW THE DETAILS OF THE BUILDING EXPANSION. FUNDING SHOULD BE RECEIVED THE 2ND HALF OF 2024.
