## **OLD BUSINESS**

A. FINANCIALS AND RIDERSHIP: FOR THE FISCAL YEAR TO DATE, REVENUES ARE AT 56% OF THE PROJECTED BUDGET WHILE EXPENSES ARE AT 42.5%. MARCH RIDERSHIP IS UP 152 OVER MARCH 2020. DUE TO THE PANDEMIC, YTD RIDERSHIP IS DOWN 41.4% FROM THE PREVIOUS YEAR.

## **B. CAPITAL GRANT PROGRESS:**

2019: THE TWO NEW PROPANE BUSES SHOULD BE DELIVERED IN MAY.

2020: THE PROPOSAL REQUEST FOR ROOF REPAIR WILL BE REISSUED DUE TO LACK OF RESPONSE. ENDEVOR (FORMALLY HAMILTON FARM BUREAU) WITH BE THE PROPANE SUPPLIER.

C. THE BILLBOARD PROJECT IS COMPLETE. THE BOARD RECOMMENDED PUTTING ANOTHER BILLBOARD ON THE OTHER SIDE OF THE SIGN STRUCTURE TO CAPTURE INTEREST. MOTION BY PULLEN TO AUTHORIZE YFF TO SPEND UP TO \$1600 PER YEAR TO MAINTAIN THE BILLBOARD. SUPPORTED BY MUNCEY. MOTION CARRIED.
