## **OLD BUSINESS**

FINANCIALS AND RIDERSHIP: THE CASH POSITION REMAINS STRONG. EXPENSES AND REVENUES HAVE REACHED 31% OF THE BUDGETED FIGURES. RIDERSHIP FOR JANUARY HIT 74% OF PREPANDEMIC NUMBERS. THE "ITA" CARRIED 2802 PASSENGERS.

## **B. CAPITAL GRANT PROGRESS:**

2019: THE \$11,000 BALANCE OF THE 2019 GRANT WILL BE USED TOWARDS THE PURCHASE OF THE 2020 GRANT FOR THE PROPANE BUS.

2020: DELIVERY OF THE THIRD PROPANE BUS MAY BE DELAYED UP TO ONE YEAR DUE TO SUPPLY CHAIN ISSUES AND LABOR SHORTAGES.

2021: THE "REQUEST FOR PROPOSALSO" HAS BEEN STARTED FOR THE TWO-WAY RADIOS AND BUS CONVERSION TO PROPANE.
