A. FINANCIAL STATUS AND RIDERSHIP: PROPERTY TAX REVENUE IS ARRIVING AND THE CASH POSITION REMAINS STRONG. WE HAVE RECEIVED 37.9% OF THE BUDGETED REVENUE AND DISBURSED 30.2% OF THE BUDGETED EXPENSES. JANUARY RIDERSHIP WAS UP 10.4% OVER THE PREVIOUS PERIOD. THE "ITA" CARRIED 3551 PASSENGERS.
