OLD BUSINESS

FINANCIALS AND RIDERSHIP: YTD REVENUES ARE UP OVER THE PRIOR YEAR. PROPERTY TAX PAYMENTS ARE ARRIVING. EXPENSES HAVE REACHED 38% OF THE BUDGETED FIGURES. RIDERSHIP FOR FEBRUARY WAS 33% HIGHER THAN FEBRUARY 2021. THE "ITA" CARRIED 2911 PASSENGERS.

B. CAPITAL GRANT PROGRESS:

2019: THE \$11,000 BALANCE OF THE 2019 GRANT WILL BE USED TOWARDS THE PURCHASE OF THE 2020 GRANT FOR THE PROPANE BUS.

2020: DELIVERY OF THE THIRD PROPANE BUS MAY BE DELAYED UP TO ONE YEAR DUE TO SUPPLY CHAIN ISSUES AND LABOR SHORTAGES.

2021: DOCUMENTS HAVE BEEN SUBMITTED TO MDOT FOR THE TWO-WAY RADIOS. SUBMISSION OF THE DOCUMENTS FOR BUS CONVERSION TO PROPANE ARE IN PROCESS.

NEW BUSINESS

A. THE BALLOT LANGUAGE FOR THE 2022 MILLAGE ELECTION WAS REVIEWED. THE RENEWAL WILL BE ON THE AUGUST 2^{ND} BALLOT.
