## **OLD BUSINESS**

FINANCIALS AND RIDERSHIP: FOR THE FISCAL YEAR TO DATE, 41% OF THE BUDGETED REVENUES HAVE BEEN RECEIVED AND 39% OF THE BUDGETED EXPENSES HAVE BEEN DISBURSED. THE 'ITA' CARRIED 2908 PASSENGERS IN FEBRUARY.

## **B. CAPITAL GRANT PROGRESS:**

2019: THE \$11,000 BALANCE OF THE 2019 GRANT WILL BE USED TOWARDS THE PURCHASE OF THE 2020 GRANT FOR THE PROPANE BUS. THIS BUS IS EXPECTED TO ARRIVE IN THE SPRING OF 2023.

2021: THE TWO-WAY RADIOS/REPEATERS ARE EXPECTED TO ARRIVE THE END OF MARCH. THE DISPATCH SOFTWARE GRANT WILL BE INCORPORATED INTO MDOT'S STATEWIDE PROCUREMENT PLAN. THE BUS CONVERSION PROJECT IS ON HOLD. YFF APPLIED FOR A PROJECT GRANT TO EXPAND THE FACILITY.

C. MTP MEMBERSHIP: 33 TRANSIT SYSTEMS PARTICIPATE IN THE VEHICLE POOL INSURANCE FUND.
