2020: THE THIRD PROPANE BUS WILL ARRIVE IN LATE SUMMER. YFF IS SOURCING A CONTRACTOR TO POUR THE CONCRETE PAD FOR THE PROPANE TANK. A VENDOR HAS BEEN CHOSEN FOR THE ROOF REPAIR. MDOT MUST APPROVE THE VENDOR BEFORE THE BID CAN BE AWARDED.
