## **OLD BUSINESS**

FINANCIALS AND RIDERSHIP: ACTUAL EXPENSES ARE AT 90% OF THE BUDGETED FIGURES WITH ONE MONTH REMAINING IN THE FISCAL YEAR. FINAL BUDGET ADJUSTMENTS WILL BE PRESENTED NEXT MONTH. RIDERSHIP INCREASED 121% OVER AUGUST 2020. THE "ITA" CARRIED 7968 PASSENGERS!

## **B. CAPITAL GRANT PROGRESS:**

2019: THE \$11,000 BALANCE OF THE 2019 GRANT WILL BE USED TOWARDS THE PURCHASE OF THE 2020 GRANT FOR THE PROPANE BUS.

2020: DELIVERY OF THE THIRD PROPANE BUS HAS BEEN DELAYED DUE TO SUPPLY CHAIN ISSUES AND LABOR SHORTAGES. 2021: CARES ACT FUNDING GRANTS FOR TWO-WAY RADIOS AND BUS CONVERSION TO PROPANE.
