## **OLD BUSINESS**

FINANCIALS AND RIDERSHIP: MOTION BY MUNCEY TO APPROVE FY2022 BUDGET ADJUSTMENT #2 WITH REVENUES OF \$1,160,245 AND EXPENSES OF \$1,033,093. SUPPORTED BY BABINSKI. MOTION CARRIED.

THE "ITA" CARRIED 58,675 PASSENGERS IN FY2022, AN INCREASE OF 27% FROM THE PRIOR YEAR.

## **B. CAPITAL GRANT PROGRESS:**

- 2019: "ITA" RECEIVED AN EXTENSION THROUGH JULY 2023 ON \$11,000 GRANT FOR 2020'S PROPANE BUS PURCHASE.
- 2020: THE THIRD PROPANE BUS IS BEING BUILT AND SCHEDULED FOR DELIVERY IN THE SPRING OF 2023.
- 2021: TELE-RAD HAS BEEN AWARDED THE BID FOR THE TWO-WAY RADIOS. THIS PROJECT SHOULD BE COMPLETED IN
- 2023. THE BUS CONVERSION QUOTES ARE DUE 10/31/22.
- 2022: THE DEBRIEFING FOR FEDERAL GRANT NOT AWARDED WAS DUE TO MORE APPLICATIONS THAN ABLE TO BE FUNDED.
