OLD BUSINESS

A. FINANCIAL STATUS AND RIDERSHIP: THE CASH POSITION REMAINS STRONG. WE HAVE RECEIVED 94.1% OF THE BUDGETED REVENUE AND DISBURSED 89.9% OF THE BUDGETED EXPENSES. RIDERSHIP INCREASED BY 38% OVER THE PRIOR PERIOD. IN AUGUST, THE ITA SET A NEW RECORD BY CARRYING 16,352 PASSENGERS!

D. CAPITAL GRANT PROGRESS: THE BUILDING CONSTRUCTION PROJECT WILL START IN OCTOBER. BABINSKI MOVED TO APPROVE USING \$185,129.07 OF LOCAL FUNDS TO PAY THE PROJECT BALANCE. SUPPORTED BY SCHNEIDER. MOTION CARRIED.
