



#### PET FRIENDLY RESPONSIBILITY TERM

1. Each room allows 1 (one) dog or 1 (one) cat, up to 8 kilos;
2. A fee of R\$532.00 +15% per week OR R\$95.00 + 15% per day will be charged for the animal's stay;
3. The updated vaccination card must be submitted via email during the booking process or presented upon check-in. No animals are allowed without a vaccination card. Guests whose animals were vaccinated fewer than 15 days before check-in are responsible for any illness their pets may contract during this period of reduced immunity. The rabies vaccine should be given within a time frame of 30 days to one year prior to check-in;
4. For staff to perform any service in the room, the presence of the guest or a signed authorization is mandatory if the animal is left alone;
5. It is mandatory to use a collar when entering and exiting with the animal; please keep the animal in your arms or in a carrier. Loose animals are not allowed in the hotel;
6. The use of hotel linens for the animal is not permitted;
7. Guests are responsible for cleaning up waste and repairing any damage caused by their animals. Charges for damaged items will be applied in accordance with the Hotel Directory available at the QRCode;
8. Animals must not be left alone in the room for extended periods when guests are away. Animals are also not allowed in common areas, such as the restaurant (per ANVISA RDC n°216/04) and the pool;
9. The guest responsible for the animal must comply with all the rules established by the "Silence Law" (Law 126 of October 5, 1977);
10. Failure to comply with rules 6 and/or 7 is subject to a fine of R\$500.00;
11. The guest is responsible for all medical and legal expenses and liabilities in the event the animal causes damage to third parties (guests, employees, or visitors) in common or restricted areas, including rooms;
12. The hotel is not liable for the care or safety of animals, or for incidents related to doors, windows, or other factors.
13. In the event that the animal dies during its stay due to natural causes or pre-existing conditions and the hotel is not responsible for the incident, the hotel shall not have any legal liability regarding the event, including removal;
14. The hotel may suspend the stay at any time in the event of rule or conduct violations.
