RELEASE AND WAIVER OF LIABILITY AT CITY HALL RANCHO CORDOVA

In consideration of having my artwork, as further described below, displayed at 2729 Prospect Park Dr., Rancho Cordova, California 95670 (hereinafter referred to as Exhibitor), I hereby agree to the following:

1. I waive and release Rancho Cordova City Hall and Cordova Community Council and its officials, officers, employees, agents and volunteers from any and every liability of loss, including, but not limited to, liability or loss for damages or personal injury or property damage related to any claim that may be filed concerning, on behalf of, or for myself, either now or in the future, that results from or is connected in any way to the artwork which I am permitting the Cordova Community Council to display at Rancho Cordova City Hall. The waiver and release applies even if the liability or loss results or is connected with the active or passive negligence of the Cordova Community Council, Rancho Cordova City Hall and/or their officials, officers, employees, agents or volunteers.
2. I acknowledge that the display of my artwork at City Hall presents known and unanticipated risks that could result in physical injury, or damage to myself or my property. I hereby assume the risk of, and responsibility for any such injury, or damage which I or my property may sustain arising out of or in any way connected with the display of my artwork, including injury or damage resulting from any acts or omissions, whether negligent or not, by or on behalf of the Cordova Community Council, City Hall and their officials, officers, employees, agents or volunteers.
3. I agree not to sue and to indemnify, and to the fullest extent available by law, defend with counsel acceptable to the Cordova Community Council and to City Hall and hold harmless the Cordova Community Council and City Hall and their officials, officers, employees, agents, and volunteers from and against any and all liability or loss, damage, claims, expenses and costs (including without limitation, attorneys' fees and costs and fees of litigation)(collectively "Liability"), related to any claim that may be filed concerning, on behalf of, or for myself and/or any other person or entity either now or in the future, that results from or is connected in any way with the display or storage of my artwork at the City Hall. This agreement to not sue and to indemnify and hold harmless applies even if the liability of loss results from or is connected with the active or passive negligence of the Cordova Community Council their officials, officers, employees, agents or volunteers.
4. This release and waiver of liability will bind me, and my heirs, successors, and assigns, and shall remain in effect so long as my artwork is displayed or stored at the Rancho Cordova City Hall.
5. This release and waiver of liability is intended to be as broad as the law permits, and shall include without limitation waiver of any and all rights that I have, or may have, with respect to the Visual Arts Rights Policy of 1990. If any portion of this release and waiver of liability is determined by a court to be invalid, the rest of the release and waiver of liability will continue in effect.
6. I agree any works of art will be considered abandoned, donated or unwanted if not picked up immediately after the event ends denoted on the Cordova Community Council website or email sent out by a Cordova Community Council staff member and will become the property of the Cordova Community Council.
7. I HAVE CAREFULLY READ THIS RELEASE AND WAIVER AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE AND WAIVER OF LIABILITY BETWEEN MYSELF, THE CORDOVA COMMUNITY COUNCIL AND I SIGN IT FREELY AND VOLUNTARILY.

Digital Submission requirements and information: By filling out the Online form your information will be used to create your art labels, please spell correctly and input pricing and titles as you want them printed.

- **TYPE YOUR INFORMATION CORRECTLY INTO THE FORM ONLINE!**
- The juror will select works on Friday night from 6 pm - 7:30 pm.
- You will receive an email on Friday night if your work was **NOT selected** for the show and you can pick up the next morning on Saturday between 8 am & 10 am.
- No entry fee. This is a juried show.
- If you have not done so already, please register as an artist on the Cordova Community Council Website. You must live or work in Rancho Cordova or have a current membership with Rancho Cordova Arts.
- **Size limits: 2D work must not be more than 36"W x 48"H & 3D work must not be more than 20"W x 18"H x 8.5"D to fit in the cases.**
- All submissions must be your own recent work, original and **not previously shown at City Hall.**
- Acceptable media: all media of two and three-dimensional artwork. 3-D must fit in the two display cases.
- **ALL 2D WORK MUST BE WIRED, FRAMED AND READY TO HANG.** No Sawtooth hanger. Improperly framed works will be declined at intake. Gallery-wrapped canvases must have painted sides, and no staples.
- Artists are responsible for all sales with buyers. Artist email will be on the label for and **all art will remain on display until the end of show.**
- All submitted work must include a completed tag provided below affixed to the back of each piece.
- **All art pieces not picked up within 48 hours from the pickup dates will become the property of the Cordova Community Council unless arrangements have been made ahead of time, see Section 6 of the Waiver.**
