

Vendor Rules, Regulations & Responsibilities

The undersigned agrees to exhibit at the Mahopac Street Festival, to be held on October 04, 2026 (rain date October 03, 2026) and to comply with the rental requirements as stated:

Vendor/Organization vehicles:

NO vehicles will be allowed on Route 6N from 10:15 am – 4:15 pm. Set up is from 9:00 am to 11:00 am. ***Any vendor arriving after 11:00 am may have their location changed with no cancellation or refund given.** Breakdown will only start after an announcement is made at 4:00 pm the same day. All displays must be completely staffed and operating during the full hours of the Street Festival.

Vendor/Organization space and location:

The 2026 Street Festival Committee agrees to supply the vendor space that shall measure no less than 10' x 10'. Vendors can purchase as many spaces as they choose. Solely the Vendor/organization shall use the contracted space as stated in their written display plans and the vendor/organization shall not assign or sublet any portion of said space.

Equipment & Clean-Up:

Vendors/Organizations must supply their own tables and equipment. Supplies must be stored neatly within said space. Vendors must keep their assigned area clean of rubbish and paper. At the conclusion of the event, the space must be left free of packing and display materials.

Vendor/organization agrees to remove all equipment, personal possessions and refuse from their space by 5:00 pm on October 4, 2026 (or in event of rain date, October 03, 2026)

***If a tent is being used, state law requires a tent to be weighted down with a minimum of 25 pounds per leg.**

Vendors requiring electricity **MUST** rent their own generator, (if must be quiet). There is NO electricity available. There are no exceptions.

All fees are non-refundable. The event has a rain date and will be held either on the original date or the rain date. We require all vendors to provide their own liability insurance coverage. By signing this agreement, your (the vendor/organization) holds the Greater Mahopac-Carmel Chamber of Commerce not responsible in the event of any injury, property damage or loss.

General Restrictions:

Management reserves the right to: Exclude or reject any applicant that, at the managers sole discretion are deemed inconsistent with the overall atmosphere of the Mahopac Street Festival, incompatible with other exhibitors; restrict or remove, without a refund, exhibitions that have been falsely entered or are deemed by Management as unsuitable objectionable. All craft vendors must only be making and selling crafts, no other items or promoting other businesses.

Exhibit restrictions:

Vendor/Organization's space must face toward the inside of Route 6N: All temporary tent structures must be open on three sides and weighted down; All vendors shall not encroach on any other vendor's space. No music is to be played at your vendor table; no pets or animals are allowed without prior approval. (Service animals excluded)

Liability:

Neither the Town of Carmel or the Greater Mahopac-Carmel Chamber of Commerce shall be held responsible against any and all claims that arise from displaying in this fair. Upon receipt of this form by the Greater Mahopac-Carmel Chamber of Commerce, this agreement shall become a binding and enforceable contract between the parties. In the event the Vendor/Organization fails to occupy or use their rented space by the opening of the Street Festival on October 04, 2026, the Vendor/Organization shall forfeit all rights to the space, all prepaid rentals, and upon demand pay any balance due.

Food Vendors:

All food vendors are required to have their Putnam County Food Vendor Board of Health permit with a copy provided to the Chamber Office no later than September 21, 2026.

In addition, ALL Vendors must provide a Certificate of Liability Insurance naming the Greater Mahopac-Carmel Chamber of Commerce as additional insured. All vendors/organizations without this above information shall be refused entry and set-up for the Street Festival.

NO ALCOHOL PERMITTED FOR SALE OR OFFERING

There are no exceptions to the rules, regulations and responsibilities stated above unless approved in writing by the Greater Mahopac-Carmel Chamber of Commerce no earlier than 10 days prior to October 04, 2026.
