



Vibrant Arena is seeking bids for providing the following purchase:

Forklift

Specific bid information may be picked up at the Administrative Office of the Vibrant Arena during regular business hours. Bid information may also be emailed to requestors.

The proposal or bid must be received by mail or in person in a sealed envelope labeled as "BID RESPONSE – "Forklift 2026" and addressed to Vibrant Arena, Attention: Rocky Jones, 1201 River Drive, Moline, IL 61265-1303, NO LATER THAN 2:00 p.m. on Tuesday, February 17, 2026. All bids will be opened and read immediately after bid closing at the Administrative Office.

All bidders shall comply with Illinois state statutes/codes, and other applicable laws and regulations. The Vibrant Arena and/or its Authority reserves the right to accept or reject any or all proposals or bids or to waive formalities in the Bidding Process, or cancel the invitation as its best interest may require, and may exercise any other rights under Illinois state statutes/codes including, but not limited to, the right to renegotiate with the lowest responsible bidder a reduction in only the price term. The Vibrant Arena also reserves the right to reject low bids received from bidders that the Vibrant Arena determines to not be responsible under criteria set forth in the IL Admin. Code. The Vibrant Arena is a tax-exempt, municipal corporation within the State of Illinois. Prospective bidders will be deemed ineligible for bid award if prospective bidder has any unsatisfied obligations with the Vibrant Arena. Bidder on project must pay prevailing wages, where applicable. This will not be an IMPACT project.

Vibrant Arena ("Owner") is seeking bids to purchase a new (non-refurbished) forklift. Owner is requesting bids for a cushion tire model and a pneumatic tire model, but will only be purchasing one-unit total after considerations of final price and specific usage requirements are considered in ideal fit for the facility. Any alternate products to what is listed, must meet or exceed the specifications listed below.

Vibrant Arena is a multipurpose facility hosting sporting, family, and concert events. The specifications listed are crucial to the maneuverability and functionality of the lift in the facility.

Other/Miscellaneous:

- Vibrant Arena is seeking an alternate bid (credit) for the trade-in of the building's Clark GPX30 fork lift. This unit has approximately 8,760 hours and was purchased new in 1998. It is currently operational but does have a coolant leak from the radiator.
- The base bid must include a minimum 1-year manufacturers full warranty. Bidders also to provide a price for 5-year extended powertrain coverage.
- Bidder must be in continuous operation for a minimum of 5 years.
- Equipment bid must have a certified local service department in the Quad City Area (Rock Island or Scott County) for warranty or service work.
- Delivery must be included in price.

Vibrant Arena will award the bid based on the proposal that is the most advantageous to the facility when all factors are considered (level of service, expertise, and price). Vibrant Arena reserves the right to accept a higher bid if the value of the product is perceived to be greater than the low bid.

Bid must be good for up to six (60) days from bid submission deadline.

Bid award date is projected to be February 19, 2026 with a desired delivery by August 20, 2026.
