- Approval to purchase lifesaving used Holmatro Extrication Equipment from Weidner.
- This equipment will be a great addition to the equipment in the Fire Dept.
- It comes with a life time warranty.
- \$4,500.00 will come from equipment fund, move \$10,000 from the turn out rotation to the equipment fund, and we are asking for \$16,626.60. This will save us \$16,000 verses buying it new.
- **\$31,226.60** total.
- Commission offered \$25,000.00 for this purchase so there will be money left for the further needs of the Fire Department before the end of the year.
