Our price list is designed to include all of the services and fees associated with arranging a funeral. However, not everyone will choose all of these services. We make every effort to tailor each service whether it be a full funeral or an immediate disposition to the requests and budget of each individual family.

### **Explanation of Services**

#### **Professional & Staff Services**

<b>Co-ordinating Activities, Rites, Ceremonies</b> (requires facilities for shelter/preparation/embalming)	<b>\$715</b>
<ul style="list-style-type: none"> <li>Professional consultation with licensed personnel, including, but not limited to, expert advice on options to meet your needs, including essential services relating to the disposition.</li> <li>Co-ordination of all activities, rites and ceremonies before, during, and after they have been provided including services and supplies provided by us, as well as those provided by third party suppliers such as flowers and death notices.</li> <li>This fee is payable whenever we provide services to you and includes such things as 24 hour telephone &amp; staff coverage, government &amp; regulatory fees, bookkeeping and processing of memorial donations.</li> </ul>	
<b>Documentation – Permits, Forms, etc.</b>	<b>\$395</b>
<ul style="list-style-type: none"> <li>Completion &amp; filing of all documents necessary to carry out the services and supplies requested including but not limited to death registration, burial permit, coroner's certificate for cremation and documentation necessary to ship the body out of Province or Country.</li> <li>Provision of up to 15 proof of death certificates issued by Neuman Family Funeral Home (our proofs of death are usually accepted for most estate settlement purposes, but sometimes a Provincial "death certificate" will be necessary and is available from the Office of the Registrar General)</li> <li>Requests for additional proof of death certificates will be available at a cost of \$20 per copy.</li> <li>Notification to government agencies and completion of C.P.P. application forms and any assistance with life insurance notification &amp; documentation is also included.</li> </ul>	
<b>Initial Transport Remains –</b> (requires use of general duty vehicle)	<b>\$250</b>
<ul style="list-style-type: none"> <li>Transportation of the remains from one place to another, for example, the hospital to our premises or from our premises to a cemetery or other location using a transfer vehicle for distances not exceeding 50 km.</li> </ul>	
<b>Basic Preparation of Remains</b>	<b>\$200</b>
<ul style="list-style-type: none"> <li>Preparation of the body for placements into the casket including bathing, dressing and the setting of the facial features for identification or viewing without embalming. This charge applies whenever we provide services to you and includes the basic handling-moving of deceased to and from removal cot and topical disinfection and shrouding in cases of direct disposition.</li> </ul>	

<b>Embalming of Remains</b> (requires basic preparation of remains)	\$400
<ul style="list-style-type: none"> <li>Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration and temporary preservation. Embalming is not legally required but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased. Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs.</li> <li>It is our funeral home policy that embalming be performed whenever public open casket visitation is requested.</li> </ul>	
<b>Facilities for Preparation/Embalming/Shelter</b>	\$300
<ul style="list-style-type: none"> <li>Facilities used to prepare, embalm or shelter the body.</li> <li>This charge applies whenever we provide services to you and also includes the use of our general and common areas, parking areas, public washrooms, arrangement office, casket selection room, heating, lighting and maintenance.</li> </ul>	
<b>Staff Services for Visitation</b>	\$440
<ul style="list-style-type: none"> <li>Staff to co-ordinate and oversee the visitation (informal gathering) for a period of up to 4 hours.</li> <li>This includes the arrangement of casket or urn, floral tributes, photos &amp; personal items and the processing of memorial donations.</li> <li>Whenever same day visitation &amp; ceremony is requested, there will be a combined charge for staff services for both the visitation &amp; ceremony and will be shown in the visitation section of the contract and no separate charge for staff for ceremony will appear on the contract. (The charge for this request is.....)</li> <li>If the visitation takes place at an off-site location, an equipment charge will apply and will be shown under other services &amp; supplies.</li> </ul>	(\$695)
<b>Facilities for Visitation</b> (requires staff services for visitation)	\$375
<ul style="list-style-type: none"> <li>Designated facilities used for visitation for a period of up to 4 hours.</li> <li>This includes the use of all furnishings and equipment for the requested visitation period which may include any or all of the following: flower stands, easels and picture boards, lecterns, register stand, crucifix, kneeling bench, candle holders, music system, casket bier or church truck, urn display table and any other available furnishings as required for the individual request of the family.</li> </ul>	
<b>Staff Services for Ceremony</b>	\$440
<ul style="list-style-type: none"> <li>Staff to co-ordinate and oversee the ceremony or memorial service.</li> <li>This includes the services of a licensed funeral director and other staff as required to prepare for and carry out the requested ceremony or service including the arrangement of the casket or urn, arrangement of floral tributes and other related items in our chapel or other facility, and the care and delivery of the casket or urn and local tributes to a cemetery or other locations.</li> </ul>	
<ul style="list-style-type: none"> <li>Complete charge for staff for a grave-side service.</li> </ul>	\$350

<b>Facilities for Ceremony</b> (requires staff services for ceremony)	<b>\$375</b>
<ul style="list-style-type: none"> <li>• Designated facilities used for the ceremony or memorial service.</li> <li>• This includes the use of any or all items as listed under facilities for visitation.</li> </ul>	
<b>General Duty Vehicle</b>	<b>\$185</b>
<ul style="list-style-type: none"> <li>• This is an unmarked van used for the initial transfer of deceased, making funeral arrangements, obtaining &amp; registering documentation, delivery of notices and floral tributes or other necessary duties in conjunction with the service arrangements.</li> </ul>	
<b>Funeral Coach</b>	<b>\$350</b>
<ul style="list-style-type: none"> <li>• This is a specialized funeral vehicle for the transportation of the casketed remains from our facility to the place of final disposition or from our facility to the location of the ceremony.</li> <li>• In cases of winter services, this vehicle is used to transfer the casketed remains to the winter burial vault and may be used again in the spring when the burial is completed at no additional cost.</li> </ul>	
<b>Clergy/Lead Vehicle</b>	<b>\$80</b>
<ul style="list-style-type: none"> <li>• This vehicle is used for the transfer of the clergy to &amp; from the location of the ceremony to the place of interment. It is also used in leading the procession from location of ceremony to place of interment or for delivery of cremated remains to location of interment/entombment following ceremony or memorial service</li> </ul>	
<b>Other Services or Supplies</b>	
<b>Additional Mileage</b> (requires use of general duty vehicle)	
<ul style="list-style-type: none"> <li>• This charge applies for any transfer of the deceased to or from our facility beyond our 50 km service radius and is calculated at a rate of \$1.68/Km each way</li> </ul>	
<b>Funeral Stationery</b>	<b>\$205</b>
<ul style="list-style-type: none"> <li>• This charge includes the provision of a guest register, unlimited thank-you and acknowledgement cards and the inclusion in our after-care program, AfterLoss</li> </ul>	
<b>Equipment for Visitation &amp; or Ceremony at Another Location</b>	<b>\$275</b>
<ul style="list-style-type: none"> <li>• Delivery, setup and use of equipment necessary for visitation/ceremony at a location other than our funeral establishment.</li> </ul>	
<b>Additional Staff Services for Visitation</b>	<b>\$275</b>
<ul style="list-style-type: none"> <li>• Staff to co-ordinate and oversee the visitation (informal gathering) for a period of 2 hours.</li> </ul>	

## **Disbursements**

Disbursements are items arranged for and possibly paid for on your behalf by us. You are expected to pay for these items at the time the contract is entered into. The following are some items that are often identified as disbursements:

### **Coroner's Fee**

- This is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner of Ontario.

### **Clergy Honourarium**

- This is the amount paid to the clergy for their services. In some cases the amount is set by the clergy and in others it is the amount determined by the individual family.

### **Newspaper/Radio Notices**

- These are charges for death notices placed in newspaper, radio or other media outlets.

### **Municipal Death Registration Fee**

- This is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary.

### **Interment Fee**

- This is a fee charged by a private individual for the opening and closing of a grave for the placement of either casketed remains or cremation urn in a cemetery. This fee is set by this person and may vary.

### **Church Donation**

- This fee is for the use of a church facility for visitation/ceremony/reception and is often set at the determination of the individual family. In some cases, a pre-determined fee will be set by the individual facility.

### **Winter Vault Storage**

- This is a fee set by the cemetery where the winter vault is located for the temporary entombment of casketed remains until the interment can be completed in the spring.

### **Cemetery Equipment**

- This is the charge for the use of the artificial grass and lowering device when no concrete outer vault is requested.

### **Other**

- Periodically a family may have a specific request for other disbursements that they wish for us to include and pay for on their behalf which might include such things as organist or soloist, piper, monument engraving, floral tributes, catering services, etc.
