

Guidance for Refusing Law Enforcement Service

If you choose to refuse law enforcement service, please follow the below guidance:

- Always make sure any interaction is recorded.
- If approached by police do your best to ignore.
- If persistent say "I do not wish to make joinder nor contract with you."
- If still persistent ask questions, do not answer questions.
- You are not lawfully obliged to provide any of your details.

If told to leave the area:

Response:

- 1. You are supposed to engage, encourage and explain, you have skipped to enforce which means you are acting unlawfully and I am refusing your service. What is your name and badge number?
 - If persistent:
- 2. Is this a request or an order?
 - a. Answer: order, say: you have now made a contract with me and under the Modern Slavery Act 2015 I cannot complete an order without payment, therefore I will charge [£1000 per hour] to you personally, not the police federation or the state, for the completion of the order (then leave the area)
 - b. Answer 'request': I decline your request and any further trespass will be considered a breach of your oath

If told to provide details:

Questions:

- 1. Is there a lawful obligation for me to answer your question? And;
- 2. am I obliged to answer your question?
- 3. I am aware of my right to remain silent, unless under lawful obligation to provide details, please confirm a crime has been committed and therefore I am obliged to answer?
 - If persistent:
- 4. Is this a request or an order?
 - a. Answer: order, say: you have now made a contract with me and under the Modern Slavery Act 2015 I cannot complete an order without payment, therefore I will charge [£1000 per hour] to you personally and not the police federation or the state for the completion of the order (provide details under duress)



b. Answer: request, say: I decline your request and any further trespass will be considered a breach of your oath

If persistent:

5. I will provide details under duress and will be charging you personally, not the police federation or the state, my fee of [£1000 per hour].

If taken into custody, when asked for your name at the station respond with:

- 1. "I shall give my name under duress"
- 2. "My name is [first name] of the [surname] family"

If required to sign, write 'V.C.' (Vi Coactus) before your signature. This indicates you have signed under duress and therefore no contract is made. Sign with red pen where possible.

An officer must be able to provide proof that a crim

An officer must be able to provide proof that a crime has been committed and that there is a victim for detainment or arrest to be lawful. If the officer chooses to use The Health Protection (Coronavirus) Regulations 2020 you must remind the officer/s that you do not consent to the Regulation and Regulations are governed by consent. No rules, regulations, acts, or laws can infringe on your unalienable rights.

State that you do not consent to the regulation, and even if it was law, no laws can infringe on your unalienable rights of freedom of assembly, freedom of travel, freedom of speech.

Natural Law is given by birth which cannot be infringed upon by any rules, regulations, acts or laws.

If the officer threatens you with fines and arrest say "I am now putting you on notice and will be charging a fee". Then read the notice and give it to them (notice available to download).

Always remember your power, stay calm, and act in honour.
