**GENERAL INFORMATION**

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers and newspaper notices. The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected. Certain funeral services may be provided off premises by other funeral service providers.

**PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF**

Basic Services of Funeral Director and Staff \$2,250.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

Our professional service charge includes but is not limited to, consultation with family and others; procurement, preparation and filing of necessary notices, authorizations and consents; custody of the body, filing of death certificate and obtaining permits; general administrative and record keeping, other general operation expense and supervision of minimum activities; supervision and attendants for arrangement of funeral services; other services prior to and following the funeral including coordinating with those providing other portions of the funeral, such as cemetery and crematory.

**USE OF FUNERAL HOME FACILITIES**

A. Facilities and Staff for Visitation and/or Public Viewing

One night and portion of any day (not to exceed 2 days) \$ 250.00

Day of service (not to exceed 2 hours) \$ 195.00

Our Charge Includes: The use of the facilities and room in which visitation takes place, staff, and equipment when conducted at Obaugh Funeral Home. The use of staff and necessary equipment to setup the visitation, such as register stand, flower stands and casket truck when conducted at other location.

B. Facilities and Staff for Private Viewing \$ 150.00

Our Charge Includes: Use of the facilities, visitation room, and staff supervision for private viewing of unembalmed body (not to exceed 1 hour).

**This charge is not for identification purposes.**

C. Facilities and Staff for Funeral Ceremony \$ 380.00

Our Charge Includes: The use of the chapel and related equipment, including flower stands, casket truck and sound system. Supervision of the funeral and assisting staff members.

D. Equipment and Staff for a Church Service \$ 380.00

Our Charge Includes: The use of necessary equipment to conduct church service, including flower stands, church truck and register stand. Supervision of funeral, transfer of encased remains from funeral home to church, church setup and assisting members.

E. Equipment and Staff for a Graveside Service \$ 280.00

Our Charge Includes: Supervision of the graveside service and burial, accompaniment of encased remains, as well as assisting staff members. Use of related equipment such as: tent, chairs, and ground cover.

F. Facilities and Staff for a Memorial Service (Without Remains) \$ 280.00

Our Charge Includes: The use of the chapel and related equipment, including flower stands, register stand and music. Supervision of the service and assisting staff members when conducted at Obaugh Funeral Home. Necessary equipment to setup memorial service, supervision of service, accompaniment of remains, and assisting staff members when conducted at outside location.

G. Equipment and Staff for a Graveside Memorial Service \$ 330.00

Our charge includes: Supervision of the memorial graveside service and inurnment, assisting staff members, construction of graveside area; use of tent, chairs, ground cover and register stand.

H. An additional fee (overtime fee) will be applied to funeral, church, graveside, or memorial services conducted on weekends.

Not to be applied more than once. \$ 395.00

**EMBALMING**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

A. Normal Remains \$ 550.00

B. Autopsied and/or Organ/Tissue Donor Remains \$ 700.00

**Other Preparation of the Deceased**

A. Casketing, Dressing, Cosmetic Application, Composing \$ 125.00

B. Alternate Care of Remains. Bathing & Surface Disinfection \$ 125.00

C. Bathing, Surface Disinfection, Dressing & Casketing of Remains that are **NOT** Embalmed \$ 375.00

D. Mechanical Device Extraction & Disposal Fee \$ 95.00

E. Refrigeration of Remains (per day) \$ 60.00

Refrigeration of an unembalmed body will be applied 24 hours after assuming custody of remains. Under certain circumstances, the condition of the remains may require immediate refrigeration. Refrigeration of an embalmed body may be applied per day when extra preservation efforts need to be taken to meet the client family's request.

**IMMEDIATE BURIAL (Without Ceremony)**

\$2,775.00 to \$9,525.00

Our Charge Include: transfer of the remains to funeral establishment, basic services of funeral director and staff and use of hearse to cemetery. **It is the policy of Obaugh Funeral Home that all Immediate Burials are carried out within 24 hours of taking custody of deceased.**

**DIRECT CREMATION**

\$3,025.00 to \$7,475.00

Our Charge Includes: Transfer of remains to funeral establishment, basic services of funeral director and staff, transportation to/from crematory; as well as the cremation process, \$375.00.

State and local laws do not require a casket for direct cremation.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are heavy cardboard/particle board boxes.
