Explanatory Notes

1. Proposers and seconders must be current playing members of the Club.
2. This application form must normally be signed by a proposer and a seconder. There are a number of exemptions to this requirement and these are set out below.
3. Where the parent of guardian proposes their child's application for Cadet, Junior or Colt membership no seconder is required.
4. Where the applicant for Cadet or Junior membership is not the child of a member, the proposer and seconder must be aged 18 years or older.
5. Where the application is for Partner membership, the nomination must be proposed by the candidate's partner who must be a Full Playing or 6 Day member. No seconder is required.
6. Where the applicant for any category of membership is transferring from a reciprocal club, the requirement for a proposer and seconder shall not apply. A letter of introduction or referral from the applicant's reciprocal club must be obtained.
7. Where the applicant does not have a proposer and seconder the application must be accompanied by three written references from people who have personally known the applicant for a period of at least one year.
8. Social membership does not require a proposer and seconder.
