#### **Identification of Deceased -**

Private viewing in cremation container for up to 6 family members to view the deceased for a 30-minute duration before cremation takes place. This includes minimal preparation of the deceased as well as facilities for identification.

**Note:** This service can only be performed on deceased individuals who have not undergone any post-mortem examinations. Should you want to see your loved one and a post-mortem examination has been completed, a fee of \$525.00 for embalming of remains will be applied to the contract total.

**Note:** With any identification, we require a viewable wooden container be selected.

#### **Proof of Death Certificates**

Note: For additional certified Proof of Death Certificates a fee of \$5.00 per copy will be applied. For certified Proof of Death Certificate from archive (older than 1 year from date of request): \$20.00 per copy will be applied.

#### Transport Remains (From Place of Death)

(within 75 kms of our facility; additional fees apply beyond 75 kms of \$2.00 per km) both ways

- Transportation of the remains from one place to another; for example, from the place of death (hospital, long term care facility, residence, etc.) to the holding facility. A charge applies for each transportation need and request.
- If an additional staff member is required to transport remains: **\$100.00** will be applied to contract.

#### Facilities for Sheltering of Remains — \$100.00

Facilities used to prepare and shelter the deceased body prior to cremation. This facility is constructed with requirements from the Bereavement Authority of Ontario laws and regulations and is annually inspected by the Ministry of Health.

#### Vehicle Requirements

• The use of this specialized vehicle includes the transportation of the deceased from the holding facility to the cemetery or crematorium.

General Purpose Vehicle

This vehicle is used by our staff when making arrangements for the procurement and registration of necessary documents or any other trips that are in conjunction with services being performed by us. This is a flat rate charge for all services performed.

#### **Additional Services**

#### Cremation with Rushnell Crematoriums Inc. — \$850.00 (Tax Included)

- Cremation through our own local crematorium ensuring that your loved one will never leave our care.

Note: Rushnell Crematoriums Inc. will not cremate human remains if there are any radioactive implants, unless (a) it is at least two years after the day the body received the implant; or (b) a lesser time has passed since the body received the implant, and it is safe to cremate the body.

#### Expedited Cremation — \$226.00 (Tax Included)

• If remains are required in less than 3 business days.

Note: The cremation process will not take place on weekends.

Oversize Cremation — \$895.00 (Tax Included)

• Cremation process that requires an additional amount of time and fuel while using an OS crematorium retort.

- Witnessing Cremation \_\_\_\_\_\_\_ \$333.00 (Tax Included)
   We allow witnessing of the initial cremation process at Rushnell Crematoriums Inc.
- A private time for immediate family members to attend the start of a cremation.

#### **Delivery of Items** — \$125.00

• Our staff will deliver any necessary documentation and or deliver cremated remains to your door. Additional fees beyond 20 km from our facility, a charge of \$2.00 per kilometre, cost based on distance and charged per kilometre both ways from our establishment. To and from the destination will apply.

#### Refundable Deposit for Cremated Remains — \$350.00

• When human remains are to be cremated, a refundable deposit will be required to be paid. If the cremated remains are not claimed within one (1) year from the date of cremation, the deposit may be used to inter the remains in common ground at a cemetery of the transfer services choice. If the cremated remains are claimed before they are interred, the deposit will be refunded.

#### Refrigerated Holding Facility \$84.75/day (Tax Included) Required if there is a delay in arrangements beyond 3 business days. Body Shroud/Pouch — \$100.00 • Use of Body Shroud/Pouch to contain the deceased when being placed in a cremation container or casket when embalming is not selected and/or not authorized. Cremated Remains Handling Fee If a client wishes to have their own supplied cremation receptacle to be filled, we will charge a handling fee per item to do so. Please allow up to 24 hours for completion. Pacemaker Removal/Disposal — \$125.00 • A licensed Funeral Director will be dispatched for the removal of any pacemaker or such like implant in order for the cremation process to take place. Shipping Cremated Remains — (Rates May Vary) • Within Ontario - \$125.00 (Includes Postage) Within Canada - \$225.00 (Includes Postage) International - \$525.00 (Includes Postage, does not include air cargo) Additional Mileage — \$2.00/km (both ways) • When travelling beyond 75 km from our facility, a charge of \$2.00 per kilometre, cost based on distance and charged per kilometre both ways from our establishment. To and from the

destination will apply. Plus use of a transfer vehicle at \$195.00.

There will be a charge of \$75.00 for any non-sufficient (NSF) cheques returned by the bank.
