Enfield Town Overground Station is approximately 300m away, providing rail services to Liverpool Street, via Seven sisters (Victoria Line Underground) and Enfield Chase Overground Station is approximately half a mile to the west with direct services to Moorgate via Finsbury Park (Piccadilly and Victoria Underground lines) and Hertford.

Junctions 24 & 25 of the M25 are both approximately 3 miles to the north and the A10 is less than a mile to the east, providing access to the North Circular Road (A406) to the south.
