Ultimately, providing Employees with the highest level of education and training that successfully prepares them for in-service orientation and onboarding.





## **Register For Training**

### **Prerequisites & Qualifications**

The Bylaw Enforcement Officer Certification training program is designed for applicants who are 18 years of age and are applying for a job in Bylaw Enforcement or are already employed by a municipal or regional government.

### **Training Locations**

All training is conducted at one of three Skills Training Centres (STC) in Ontario.

#### **Accommodations**

Depending on the designated training location, accommodations are available for students at discounted rates. Payment for which is the sole responsibility of the student and/or employer.

#### **Equipment**

With the exception of in-service duty equipment. Canadian Security Training provides all required training equipment and materials. Ensuring participants get an opportunity to learn and train in a professional environment.
