General Price List

We are proud to present the following services and fee schedule of Lombard Funeral Home. These prices are effective January 1, 2025 but thereafter are subject to change without notice.

The goods and services shown below are those we can provide to our families. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for basic services and overhead. If legal or other requirements mean you must buy any items or services you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you select.

This list does not include prices for certain items you may ask us to buy for you, such as paid newspaper notices, certified copies of the death certificate, cemetery services or crematory services. The prices for those items will be shown on your bill or statement describing the funeral good and services you select.

Our goal is to sensitively and professionally fulfill all of your funeral and memorial needs. If something is not clear or you have a specific request which you cannot find in this packet, please do not hesitate to ask.

Our Funeral Payment Policy

We at Lombard Funeral Home stand ready to assist your family at this difficult time. We take this opportunity to thank you for the trust and confidence that you have placed in us.

Being a small business, we are totally dependent upon our families for prompt payment.

Two types of expenses are incurred in the course of funeral arranging: fees incurred by third parties (such as clergy, cemetery, death certificates and newspaper notices) known as cash advances and fees incurred for services performed by us.

We request a minimum of one-half of the total funeral expenses be paid prior to the funeral service. Payment may be made by cash, check, credit card, funeral trust account or by life insurance if policy can be validated (beneficiary/value) and is assignable. The balance is due 14 days from the date of death unless other arrangements have been agreed upon.

Basic Services of Director and Staff **\$3,150.00**

This charge includes consultation with the family to determine their wishes for funeral services and to acquire the information needed to carry out those wishes. It also includes the notification of clergy, cemetery, organizations and coordinating with them and others the completion of the services requested. Preparation and filing of necessary authorizations and permits; recording vital statistics; ordering of certified death certificates; composition and submission of local obituary notice. Also included in this charge are overhead expenses relative to our facility, such as professional licensing, parking lot and grounds, secretarial and administrative expenses.

This fee is already included in our charges for direct cremation, immediate burial and forwarding or receiving remains.

Embalming **\$ 750.00**

Except in certain cases, embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements such as funeral with visitation. If you do not want embalming you have the right to choose an arrangement which does not require embalming take place such as direct cremation or immediate burial.

Organ Donation Restoration **\$ 175.00**

Sanitary Care **\$ 350.00**

Washing and disinfecting un-embalmed remains for immediate burial/cremation.

Dressing, casketing and cosmetology **\$ 380.00**

Use of facilities and staff for visitation/celebration of life (up to 4hrs) **\$ 790.00**

Our services include use of facilities, set-up, display of floral arrangements, professional staff supervision and attendance during the visitation.

Limited viewing/private visitation \$250.00/hour

Saturday/Sunday, Spring/delayed services may be subject to an additional \$300.00

Use of facilities and staff for Funeral/ Ceremony/Life celebration **\$ 890.00**

Our services include professional staff coordination and supervision of funeral ceremony at funeral home and/or church or other facility as well as set-up and use of facility. Also includes burial and or graveside service on same day.

Saturday/Sunday, Spring/delayed services may be subject to an additional \$300.00

Transfer of deceased to funeral home from place of death. (Local) **\$ 580.00**

An additional mileage charge of \$3.00 per mile after the first 25 miles will be charged.

Automotive Equipment additional mileage charge of \$3.00 per mile after the first 25 miles and overtime charges after 3.5hrs from dispatch per livery company.

Hearse for funeral services or transfer to crematory **\$490.00**

Safety/ lead car /flower car/utility vehicle **\$385.00**

Limousine **\$450.00**

Additional services and facilities available

Equipment for Graveside Ceremony/Alternative Ceremony **\$295.00 - \$495.00**

This may include: Tents, Chairs, Lowering Devices, Video and Sound, Tables and other necessary items to conduct requested services.

Memorial Service/Celebration of Life in our facility, church or other facility **\$790.00**

Our services include professional staff coordination and supervision of the memorial service and set-up of church or facility for memorial service including flowers and any other memorial items.

Graveside Ceremony/Spring Burial **\$ 690.00**

Our services include professional staff coordination and supervision of the graveside service. This fee only applies when burial does not occur immediately following a funeral service. This applies to both full and cremation burials as well as Spring Burials.

Weekend, Spring/delayed, services/burials may be subject to an additional \$300.00

Anatomical Gift **\$2,725.00**

Our services include professional staff consultation with family, coordination with medical facility, transfer from place of death, transfer to medical facility, preparation and filing necessary authorizations and permits, recording vital statistics, composition and submission of local obituary notice.

Direct cremation **\$3,990.00**

Our charge for direct cremation, without ceremony, includes: local transfer and shelter of deceased for 48-hour legal waiting period, transportation to local crematory, necessary services of directors and staff, procurement of vital statistics, required documents and authorizations.

If you arrange a direct cremation, you may use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard. The containers we have available are; minimum alternative containers, cloth covered casket or a wood casket. The containers/caskets are subject to an additional charge.

Minimum alternative container **\$ 110.00**

Additional casket choices are available for cremation.

Not included are the following cash advance items; Cremation Permit, Certified copies of the death certificate, Medical Examiner's fee, Cremation fee, Newspaper tribute/notices.

Cremated remains are returned to the funeral home in a temporary container.

Immediate Burial **\$3,900.00**

Our charge for immediate burial, without ceremony, includes: local transfer and shelter of deceased, local transportation to cemetery, necessary services of directors and staff, procurement of vital statistics, required documents and authorizations.

Not included are the casket, outer burial container, cemetery charges, newspaper tribute/notices, burial permit and certified copies of the death certificate.

Forwarding deceased to another funeral home **\$3,715.00**

This charge includes: local transfer of remains, services of staff, necessary authorizations, embalming, local transfer within a twenty-five-mile radius.

Receiving deceased from another funeral home **\$3,715.00**

This charge includes: local transfer within a twenty-five-mile radius, services of staff, shelter and care of deceased, transportation of deceased to cemetery or crematory within a 25-mile radius.

Receiving cremated remains from another funeral home for ceremony or final disposition **\$ 375.00**

This charge does not include the use of facilities or staff for visitation, funeral or graveside ceremony/rites.
