

# Terms of Business Motivational Business Network (MBN)

Version 1.0

## 1 About MBN

Motivational Business Network Ltd ("MBN", "we", "us", "our") operates a private business network for approved members.

Company Registration Number: 17015149 Registered in England and Wales.

By accessing our website, applying for membership, or participating in any MBN activity, you agree to these Terms of Business.

If you do not agree, you must not use our services.

## 2 Membership Eligibility

MBN is a private, application-only network.

Membership is granted at our sole discretion. We reserve the right to accept or decline any application without explanation.

Membership:

- **Is granted to an individual or business entity**
- **Is non-transferable**
- **Remains subject to ongoing compliance with these Terms**

MBN may revoke membership if standards of conduct are not maintained.

## 3 Membership Fees and Payment

### 3.1 Fees

Membership fees are payable in advance and are exclusive of VAT unless stated otherwise.

Plans may be:

- **Monthly rolling membership**
- **Annual upfront membership (discounted where applicable)**

Annual memberships are payable in full at the start of the membership period and are non-refundable once commenced.

### 3.2 Payment Failure

If payment fails:

- **MBN may reattempt collection**
- **Access may be suspended immediately**
- **Membership will not be reinstated until all outstanding balances are cleared**

Continued non-payment may result in termination.

### 3.3 No Refund Policy

Refunds are not provided for:

- **Partial months**
- **Unused membership time**
- **Terminated memberships**

Unless explicitly agreed in writing by MBN.

## 4 Cancellation and Notice

Membership operates on a rolling basis unless an annual plan is selected.

Members may cancel at any time by providing 30 days' written notice to MBN via the official contact email.

Membership:

- **Remains active during the 30-day notice period**
- **Remains chargeable during that period**

Annual plans cannot be cancelled mid-term and are non-refundable.

Cancellation is only effective once written confirmation is acknowledged by MBN.

## 5 Behaviour and Conduct

Members agree to abide by 'Our Code' listed in this document

The following are not tolerated:

- **Misrepresentation**
- **Spamming or unsolicited selling**
- **Disruptive or abusive behaviour**
- **Breach of confidentiality**
- **Conduct that undermines trust or culture within the network**

Determination of unacceptable behaviour is at the sole discretion of MBN.

MBN reserves the right to suspend or terminate membership immediately where standards are not met.

## 6 Confidentiality

MBN operates as a private network.

Members agree not to share confidential information, private discussions, introductions, or proprietary content outside the network without explicit permission.

This obligation continues after membership ends.

## 7 Introductions and Commercial Dealings

MBN facilitates introductions and conversations but does not guarantee outcomes, revenue, contracts, or results.

MBN:

- **Does not conduct formal due diligence on members**
- **Makes no representations regarding competence, financial stability, or regulatory compliance**

All business conducted between members is undertaken at their own discretion and risk.

MBN accepts no liability for agreements, disputes, losses, or outcomes arising between members.

## 8 Intellectual Property

All MBN materials, frameworks, branding, event formats, written content, and proprietary systems remain the intellectual property of MBN unless otherwise stated.

Members may not:

- **Distribute**
- **Repurpose**

Any MBN content without prior written consent.



## 9 Events and Recordings

MBN may host online or in-person events.

We reserve the right to:

- **Change schedules**
- **Change speakers**
- **Alter formats**
- **Cancel events where necessary**

Events may be recorded.

MBN retains the right to use recordings, images, and event footage for internal training, marketing, and promotional purposes unless a member opts out in writing prior to the event.

## 10 Suspension and Termination

MBN may suspend or terminate membership immediately if:

- **Fees remain unpaid**
- **These Terms are breached**
- **Conduct damages the culture or integrity of the network**

Termination does not entitle the member to any refund.

MBN's decision to suspend or terminate membership is final.

## 11 Limitation of Liability

MBN shall not be liable for any indirect, consequential, or financial losses arising from participation in the network.

Nothing in these Terms limits liability where it cannot legally be excluded.

Between members or between members and MBN.

## 13 Data Protection

MBN processes personal data in accordance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

## 14 Website Use

You agree not to:

MBN may suspend or withdraw website access at any time.

## 15 Force Majeure
