The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

## Basic Services of Funeral Director and Staff and Overhead Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Placing Obituary or Death Notice in Newspaper ...... (per receptacle) \$25 **Embalming** Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, which does not require you to pay for it. (Please add the cost of casket and Air Tray for air transit) Receiving of Remains from Another Funeral Home \$3,185 Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory only. Visitation and services are an additional charge. Direct Cremation \$845 Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations and cremation. Other Preparation of the Body charges may apply; otherwise it is the policy of our firm to require embalming. The charge does not include the coroner's fee or the use of facilities and staff or any visitation or ceremony, public or private, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide, other than the minimum alternative container, are made of heavy fiberboard. The container we provide is a minimum alternative container. Direct Cremation with min. alternative container purchased at the funeral home .......\$995 Direct Cremation with container provided by purchaser (casket add'l charge) .......\$845 Immediate Burial Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to the cemetery. This charge does not include embalming, casket, use of facilities and staff for visitation or
