#### **VILLA RESERVATION / CANCELLATION POLICY**

To secure your reservation: 50% deposit is required at the time of booking, we accept Visa, Master & American Express cards. 100% of all fees is required for Booking made with in 90 days of arrival. If you intend to make payment via Cashiers Check or Wire Transfer, please contact us directly via our contact information. Cancellations Occurring:

61 Days and Over = No Cancellation Fee

46 - 60 days prior to date of arrival = 75% Cancellation Fee

45 days or less prior to date of arrival = 100% Cancellation Fee

All cancellations must be received in writing. There will be no refunds for late arrivals or premature departures. Cancellation Fee is calculated on the Gross amount of the Booking. You may wish to obtain trip cancellation insurance, available through your travel professional.
