#### **Tomato Glasshouse Energy**

Initially low borehole yields were improved dramatically by following an Envireau Water design based on a detailed geophysical survey of the boreholes, followed by a controlled programme of injection acidisation. The borehole system will now be capable of supporting a 500kW open loop ground source heating system that will supply heat to state-ofthe-art tomato glasshouses.

#### The Final Transitional Arrangement Applications

We have submitted over 12% of all Environment Agency applications. We met the final June deadline and submitted the last few, taking the total number of applications to 137. We'll now



be on hand to support our clients as all these applications move forward through the determination process.

#### **Limestone Quarry Gloucestershire**

Planning permission for a quarry extension was finally obtained following detailed and prolonged negotiations spanning over 4 years with the Environment Agency and Natural England regarding the longest active tufa cascade in the United Kingdom. What a result!

#### Welsh Hydroelectric Licensing

August

An existing 19th century Weir was found to be in breach of a Hydro Electric Power abstraction licence by Natural Resources Wales (NRW). Following a compliance order, Envireau Water designed a simple modification to the system and an appropriate licensing pathway before entering detailed & prolonged negotiations. NRW rescinded compliance orders, and new domestic and transfer licences were issued.
