F. SUMMARY OF ACTIVITIES OF REDEVELOPMENT COMMISSION DURING 2024

In 2024, the Ingalls TIF District received its largest disbursement of funds since it was established. This allowed the RDC to invest in several projects aimed at stimulating economic development in the District. The RDC was able to purchase real property along SR 67 for future development opportunities as well as make significant investment in infrastructure planning and economic development projects.
