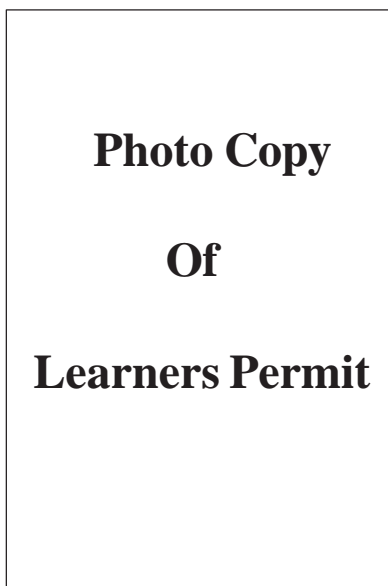

Classroom instruction tuition is \$320.00. Tuition of both classroom and behind-the-wheel instruction is \$535.00 due on or before the first class meeting unless other arrangements have been made. The student is expected to be present at each classroom session since no provisions are made for makeup work. Classroom instruction consists of 36 classroom periods of instruction and runs concurrently with the behind-the-wheel instruction.

Behind-the-wheel tuition is \$385.00 for 14 periods of instruction (Adults \$595.00). Seven periods of driving time and seven periods of observation time are provided for each student. If a scheduled driving session is missed without advance notice of at least 24 hours, the session can be made up on an alternate driving day at the fee of \$40.00 per period of make-up instruction. Remedial instruction, if required to build driving skills, is also billed at \$85.00 per period.

It is recommended that students enroll in both the classroom and the behind-the-wheel instruction to more effectively synchronize the learning experience. Note: students 17 years of age and under are required to complete a state approved driver education program (minimum 36 classroom periods, 7 driving periods, 7 observation periods) prior to receiving a driver’s license. Students not meeting the 36 classroom periods due to an absent must make that absent up in the next 36 period classroom session. BTW absent will be made up on the next available day. Students 18 years of age and older may hold the learner’s permit for 60 days in lieu of completing a driver training course.

Attitude is one of the most important attributes of a safe driver. A & C Driving School, LLC reserves the right to release any student from either the classroom and/or the behind-the-wheel segments of instruction when deemed necessary by the instructor. In the event that either the instructor or the student decides to terminate this agreement, A & C Driving School, LLC will provide a full refund up to the first day of class of behind-the-wheel and/or classroom instruction. After this time, no refunds will be given.

Instruction provided does not guarantee that any student will pass the state driver’s license examination or that the student can secure a driver’s license, or that the student will be guarantee employment upon completion of course. NOTE: There’s a \$85.00 charge for a 4th in car retest.
