ORDER

THIS MOTION, made by 11095226 CANADA FOUNDATION for judgment, was heard in writing this day, at 15 Bridge Street West, Belleville, Ontario, by videoconference.

ON READING the Motion Record of the moving party and hearing its submissions:

1. THIS COURT ORDERS that judgment be entered in favour of the moving party/plaintiff in this action, noting a finding of monetary liability of the defendant 2571883 ONTARIO INC. o/a Trident Group to the plaintiff for breach of contract and defamation, and a finding of non-monetary liability of the defendant Ryan Laliberte for defamation.
2. THIS COURT ORDERS that the defendant 2571883 ONTARIO INC. o/a Trident Group pay to the plaintiff general damages for breach of contract in the amount of \$94,098.15.
3. THIS COURT ORDERS that a further hearing be held for the determination of the quantum of the damages payable by the defendant 2571883 ONTARIO INC. o/a Trident Group in relation to this court's finding of liability for defamation.
4. THIS COURT ORDERS an immediate and permanent injunction to issue against both of the respondents/defendants restraining each of them from making or continuing to display, in any form or media, any disparaging statements about the

plaintiff, including the Defamatory Statements (as defined in the Statement of Claim in this action).

5. THIS COURT ORDERS an immediate mandatory injunction requiring both of the respondents/defendants to forthwith remove the 1st Facebook Post and the 2nd Facebook Post (as such are defined in the Statement of Claim in this action) from the internet (if not already removed), and post, in the usual manner, a copy of this Order, and any reasons for judgment in connection therewith, on the same Facebook page where the 1st Facebook Post and 2nd Facebook Post were made, if those Facebook page(s) continue to exist, and to maintain said posting(s) thereupon for 2 years. However, i) if Ryan Laliberte's Facebook page, thorough no fault of his own, is shut down/deleted/eliminated and Mr. Laliberte is unable to reactivate it despite reasonable efforts, this shall not be cause for sanction or a breach of this Order, and ii) Ryan Laliberte has no ongoing obligation to post or add anything else to his Facebook, or to maintain his page or seek any viewership (new or otherwise) to his page during the two year period that this Order is in effect.
6. THIS COURT ORDERS an immediate 2-year injunction prohibiting the defendant Laliberte from entering onto the grounds or structures located at the following addresses:
 - a. Ms Woods' home address: 461 Old Wooler Rd, Codrington, ON K0K 1R0;
 - b. Brighton Clinic: 12 Alice Street, Brighton, Ontario K0K1H0;or to speak with anyone employed by the Plaintiff at its place of business at 284B Wallbridge-Loyalist Road, Belleville, Ontario, K8N 5B9.
7. THIS COURT ORDERS that the respondent 2571883 ONTARIO INC. o/a Trident Group pay costs to the moving party in the amount of \$XX in connection with this motion and Order.
