Wayne County Kennel Application Instructions

Fee

The fee for a county Kennel License is \$90.00 and entitles a person to five numbered tags. After the January 31st deadline, an additional \$90.00 penalty will be added to your Kennel License fee. If you have more than five dogs, mandatory additional tags are \$1.00 each. Effective December 1, 2013, you must purchase a tag for each dog in your kennel that is more than three months of age.

Renew Your License by Mail

To renew your kennel license by mail, the enclosed application must be filled out, in complete detail, as well as the affidavit at the bottom of this form. Once both forms are complete, they should be returned to the Auditor's Office, along with your check made payable to *Wayne County*. Example: If you have 10 dogs, you pay \$90.00 for the first five tags and \$1.00 for each additional tag for a total cost of \$95.00.

Payment Method

If renewed by mail, you may only pay by check. If renewing at the Auditor's Office, you may pay by cash, check, or debit/credit card. There is a convenience fee when paying with a debit/credit card.
