## 1. Lessons

Lessons will take place at Little Rock Music Academy on the same day and time each week, totaling **four lessons per month**. Each lesson will last 30 minutes.

- Advanced Lessons: If a student requests an hour-long lesson, the rate will be adjusted to double the monthly fee, as agreed upon by both Teacher and Student.

## 2. Attendance Policy

- Lessons are like college classes: you're paying for the time slot, and it's **your responsibility to attend**.

- If you provide 24+ hours' notice, I will try my best (but can not guarantee) to reschedule based on other cancellations. However, you must proactively check in with me regarding available times.

- Lessons missed by me will always be made up.

## 3. Payment

The monthly fee for lessons is due at the first lesson of each month. A two-week grace period is offered for late payments. **If payment has not been received by the 3rd week, a \$10 late fee will be applied.**

You may:

- Pay in person (cash or check only) at your first lesson.
- Mail a check to: David Dunavant -Address will be provided after sign up

### A Note on Payments:

**Running my business smoothly relies on timely payments. I've built in flexibility with a grace period because I understand life gets busy. I deeply appreciate your help in keeping things on track by paying on time or within the first two weeks.**

## 4. Termination of Lessons

This agreement may be ended by either party with one month's notice.

### A Note on Ending Lessons:

I understand that life happens and priorities change, but I kindly ask for a month's notice if you decide to stop lessons. This allows me time to adjust my schedule and offer your spot to someone on the waiting list. Thank you for your thoughtfulness and understanding!
