Our comprehensive service model for medication management allows individualized care for each patient's unique needs.



#### **OUR PROCESS & SERVICES**

**Medication Therapy Review (MTR):** Our systematic process of patient-specific data collection helps our team assess therapies to identify medication-specific problems and formulate a plan to resolve them.

**Personal Medication Record (PMR):** This list allows our providers to assist the patient with overall medication therapy self-management and ensure reduced chances for inter-drug reactions or serious adverse side effects.

**Medication-related Action Plan (MAP):** The MAP details a list of actions to take (or not take) in order to track progress for achieving specific health goals while on the medications.

**Intervention and/or Referral:** Some patients require direct interaction with the pharmacist and the prescribing provider to determine if additional monitoring, patient education, or a return visit to the provider is needed.

**Documentation and Follow-up:** Documentation is intended to be a complete record of patient care steps, a detailed history of medications, past interactions, or unintended side effects.
