Authorization to Repair and Direction to Pay

The undersigned authorizes **AGM Collision Services LLC, dba Kauai Foreign Cars** to disassemble, order parts, materials and repair my vehicle to pre-loss condition. I understand that the damage to my vehicle may be more extensive than what can be seen on the exterior portions and that complete disassembly will be needed to access those areas which are not clearly visible. I understand and agree that should the cause of the damages, if any, be loss related, the Insurance Company identified, if going through insurance, has taken liability for my repairs and will pay for the total cost of those repairs to bring the vehicle to pre-loss conditions. However, if any damage is the result of normal wear and tear or a previous damage incident or is otherwise unrelated to the loss and / or is not covered by the terms of the insurance policy, I agree to pay for the disassembly and reassembly, as well as repairs. If I cancel the repairs for any reason, I will pay costs incurred for any parts ordered, parts that need to be returned, and any labor incurred to that point. I am granted permission to operate my vehicle on the street or highways for the purpose of testing or sublet work. Old / damage parts will be disposed of concurrent with Insurance Company and regulatory standards. **AGM Collision Services LLC, dba Kauai Foreign Cars**, is not responsible for the reinstalling expired safety check stickers on replaced or repairs bumpers.

AGM Collision Services LLC, dba Kauai Foreign Cars will not be responsible for any personal items left inside vehicle at drop off or during the stay of the vehicle in our shop. In case of fire, theft, weather, vandalism, collision, accident or any other cause beyond our control as well as delays caused by the unavailability of parts, supplement part orders or shipping delays, I will not hold AGM Collision Services LLC, dba Kauai Foreign Cars responsible nor will I require any compensation such as rental or monetary.

Upon the completion of repairs, I will pay all monies owed in relation to loss, i.e. – deductible, any customer authorized work. The vehicle will not be released to the owner until all owner fiduciary responsibilities are met. I will pay for the parts in full or at least 50% of the costs for any 'non insurance' or 'customer pay' claims prior to the parts being ordered as a down payment. I understand that I will have to pay for the additional damages and supplement found once my vehicle is disassembled and in the possession of AGM Collision Services. I hereby agree to pay 100% of non-returnable parts and a dealer 30% restocking fee along with any shipping and transportation charges if repairs are cancelled after parts are ordered.

I authorize **AGM Collision Services LLC, dba Kauai Foreign Cars** to accept on my behalf any and all checks, drafts, or bill of exchange. I further authorize AGM Collision Services LLC, dba Kauai Foreign Cars to act as power of attorney to sign insurance checks needed to pay for my claim. I authorize the insurance company to make supplement payments directly to shop on behalf of myself and my vehicle. If I receive payment for said repairs, I will remit said payment/s to **AGM Collision Services LLC, dba Kauai Foreign Cars** within three (3) days or receipt.
