SBOANJ Sponsored Races

The SBOANJ sponsors two major races for NJ sired or resident mare offspring.

The Home Grown Pace is open to NJ sired pacers, NJ SDF eligible horses and to NJ foaled horses.

The Garden State Trot is for NJ sired trotters only.

Both races require nominations and sustaining payments. Forms are available on the SBOANJ website.

Both events, 2 year old races and the 3 year old races are contested at The Meadowlands.

New Jersey Sire Stakes

The New Jersey Sire Stakes sponsors races for 2, and 3 year old New Jersey bred horses as well as offspring of resident mares.

These races are not sponsored by the SBOANJ.

Breeder Awards

New Jersey breeder awards pay 12% of the purse amount earned by each **New Jersey Sired horse** in divisions and finals of designated NJ races. The award amounts are determined each the year based on the number of horses raced.

NJ Sired Owner Awards

The SBOANJ administers the payments of New Jersey sired awards **on overnight events** at the Meadowlands Racetrack.

The owner of a NJ sired horse who is 6 years old or under will be paid a monetary amount based on finishing.

1st- \$1000, 2nd- \$900, 3rd- \$800, 4th- \$700,
5th- \$600

Resident Mare Rebates

For Foals of 2026

The SBOANJ will rebate up to \$1,000 to the first owner of record of a mare who has resided in NJ for 150 days, up to and including foaling.

Application forms are due into the SBOANJ office no later than October 31, 2025. A USTA/Pathway report MUST be included with the application.

2026 Rebates will be reviewed based on available funding.
