The web site may not always contain the most up to date version of this document. Fees charged will be based on the current GPL on file in the office of the Funeral Home. Payment for selected products and services is due in full at the completion of the arrangement meeting before any services can be rendered.*

### PRENEED DISCLOSURE

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

### PRICING INFORMATION

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

We have outlined a price list of "packaged" goods and services, as well as "ala carte" pricing to help guide you through our multiple service options. You should decide if you want to use package pricing OR ala carte pricing. Generally, the package pricing will unlock considerable savings to your family over the ala carte option. The Basic Service Fee is included in all our packages, however, if you do not select a package, and use ala carte selection, the basic service fee will be charged, and all other selected items will be added to it. If you do opt for one of our packages, you may not make substitutions or deletions, and the package must remain as priced, regardless of whether you use a particular item or not. Although services may be selected from the itemized portion of the General Price List, the following list of commonly selected services packages may ease the process of making arrangements.

## SERVICE PACKAGES

The following packages include only the items specifically listed in the package.

**All the packages listed below include:** Services of Funeral Director and Staff, obtaining and filing all necessary legal documentation, one staff member removal of the deceased from the place of death to our Funeral Home, within 30 miles of our location. *(If death occurs outside of 30-mile radius, or a second staff member is necessary to complete the removal, additional charges will apply.)*

### TRADITIONAL SERVICE/CHURCH WITH PROCESSION TO CEMETERY – Package Price: \$3675

Basic services and overhead fee, direction and coordination of service, set up at church/other facility, service continued to graveside, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, automotive equipment (funeral coach, flower van/utility vehicle), standard registration book, and 25 memorial folders/acknowledgement cards.

### TRADITIONAL SERVICE/PARK VIEW CHAPEL TO GRAVESIDE – Package Price: \$3475

Basic services and overhead fee, direction and coordination of service, use of facilities for Funeral Ceremony, service continued to graveside, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, automotive equipment (funeral coach, flower van/utility vehicle), standard registration book, and 25 memorial folders/acknowledgement cards.

**TRADITIONAL SERVICE/PARK VIEW CHAPEL CONCLUSION – Package Price: \$3375**

Basic services and overhead fee, direction and coordination of service, use of facilities for Funeral Ceremony, service concludes in chapel, transfer of remains to graveside, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, and unaccompanied transfer of the casket to local cemetery, standard registration book, and 25 memorial folders/acknowledgement cards.

**TRADITIONAL GRAVESIDE SERVICE: \$3275**

Basic services and overhead fee, direction and coordination of service, transfer of remains to graveside within 20 miles, set up at graveside for Funeral Ceremony, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, automotive equipment (funeral coach, flower van/utility vehicle), standard registration book, and 25 memorial folders/acknowledgement cards.

**TRADITIONAL SERVICE/PARK VIEW CHAPEL - WITH CREMATION – at a later date\* – Package Price: \$3525**

Basic services and overhead fee, direction and coordination of service, use of facilities for Funeral Ceremony, service concludes in chapel, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, standard registration book, 25 memorial folders/acknowledgement cards, pre-cremation container, cremation process, and a temporary plastic container. The cremation will be scheduled for some time after the conclusion of the funeral service, at the discretion of the funeral director; no witnessing of the cremation is included with this package. All cremations are done at our facility and are not

shipped elsewhere.

**TRADITIONAL SERVICE/PARK VIEW CHAPEL - WITH CREMATION WITNESS\* – Package Price: \$3825**

Basic services and overhead fee, direction and coordination of service, use of facilities for Funeral Ceremony, service concludes in chapel, all necessary refrigeration, washing, disinfecting, embalming, dressing, casketing, cosmetology and hair preparation, standard registration book, 25 memorial folders/acknowledgement cards, pre-cremation container, cremation process, and a temporary plastic container. Cremation will be scheduled and performed Directly following the service, and family will be able to witness the cremation. All cremations are done at our facility and are not shipped elsewhere.

**CREMATION WITH CHAPEL MEMORIAL SERVICE\* – Package Price: \$2495**

Basic services and overhead fee, direction and coordination of service, all necessary refrigeration, pre-cremation container, cremation process, temporary plastic container, use of chapel and facilities for memorial service, standard registration book, and 25 memorial folders/acknowledgement cards. All cremations are done at our facility and are not shipped elsewhere.

**DIRECT CREMATION\* – Package Prices: \$995 to \$1395**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). Our charges for a direct cremation (cremation without ceremony) includes: basic services and overhead fee, standard removal of remains within our local service area, all necessary refrigeration, minimum alternative container, cremation process, and one utility plastic container. All cremations are done at our facility and are not shipped elsewhere. The alternative container we provide is a sturdy cardboard container.

- A. Direct Cremation – Normal price where casket or alternative container is provided by customer..... \$1395
- B. Direct Cremation – *Discounted price with alternative container or casket purchased through Park View*..... \$995

*\*Note~ Please note that ANY cremation arrangements for individuals over 299lbs will require additional fees added to the direct cremation price stated above: 300-399 lbs add \$200; 400-499 lbs add \$400; 500-599 lbs add \$750; 600-699 lbs add \$1000; 700-799 lbs add \$1250; 800-900 lbs add \$1500. Our maximum cremation size is 900 Pounds. In addition to these added cremation fees, there will also be a "Bariatric Case Fee" of \$395 for any case over 350 pounds (for all necessary transports); as well as an Air Tray fee when a casket is not selected (as the standard alternative cremation container will not work).*

**DIRECT BURIAL – Package Prices: \$1295 to \$1995**

Our charge for a Direct Burial (a burial without service, ceremony, or gathering at the graveside) includes: basic services and overhead fee, standard removal of remains within our local service area, all necessary refrigeration, casketing of remains, and unaccompanied delivery of remains to any cemetery in the local service area.

### D. Direct Cremation:

Our charge for a direct cremation (cremation without ceremony) includes: basic services of funeral director and staff, standard removal of remains within Our local service area, all necessary refrigeration, pre-cremation container, cremation process, and a temporary plastic container. All cremations are done at our facility and are not shipped elsewhere.

Infant (under 20 weeks gestation): **\$450**

Infant (over 20 weeks gestations to 2 years old): **\$650**

## ITEMIZATION OF PRICES

The goods and services listed below are those we can provide to our customers. You may choose only those items you desire. However, any arrangement you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

## BASIC SERVICES FEE

**\$1700**

This fee for our basic services and overhead and will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for Direct Cremation, Direct Burial, and Forwarding or Receiving Remains. It is also included in all of our Service Packages.

## REMOVAL AND TRANSPORTATION OF REMAINS TO FUNERAL HOME:

**\$400**

This includes single man removals 24/7/365 within 30 miles from our funeral home. For transport over 30 miles the charge will be the total number of miles times \$5 per mile. Second attendants are needed in some cases and an additional fee will apply. (Note: Decedents weighing over 300 pounds will require use of bariatric gurney and may require a second attendant as well. See "Other Care of Decedent.")

*\*Note: While the standard removal fee noted above is included in our packages, any case that requires transport OVER 30 miles from our funeral home will have an additional charge of \$5 per mile, one way, from our funeral home to the location of the body. Example: 45 miles from funeral home would carry an additional charge of \$225 (45 x \$5).*

## PROFESSIONAL EMBALMING

**\$500**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or direct burial. Embalming is a chemical process, which provides temporary preservation of the body. *\*Note: Add \$200 for embalming of a person 300 pounds or more.*

If you select a funeral, which requires embalming, such as a funeral with viewing, you may have to pay for embalming. You do not have to pay for embalming that you did not approve of, such as in the case of direct burial or direct cremation.

**PROTECTIVE:** These caskets are designed by the manufacturers to resist the entrance of air, moisture, and other outside elements. They may be constructed of varying gauges of steel, copper, or bronze.

**NON-PROTECTIVE:** These caskets are not designed by the manufacturers to resist the entrance of air, moisture, and other outside elements. They may be constructed of metal, hardwood or wood products, or wood covered with fabric.

### **RENTAL CASKET \$1095**

This is for the use of a rental casket for the funeral service only. At the end of the service the alternative container will be removed, and the casket will remain the property of Park View Cemetery & Funeral Home. Our price does include the purchase of the inserted alternative container.

### **DEFINITIONS OF SIMPLE SERVICES**

We endeavor to ensure that we always provide affordable and low-cost options for the families of our community. A “*Direct Cremation*” is a cremation without service, ceremony, embalming, viewing, visitation, or witnessing of the cremation by the family. An “*Direct Burial*” is the burial of a casketed body without embalming, preparation, viewing, visitation, or witnessing of the burial by the family. We price our Direct Cremation and Direct Burial options based on the definitions and limitations above. We are often asked to start with one of these simple service packages, and then add some of the very things that the definitions above exclude. Any request to add services (embalming, viewing, ID viewing, witness burial or cremation) to the above definition changes the scope of our work and adds time and overhead cost to the services. If this occurs, we must ensure that we collect appropriate amounts to cover the additional time and overhead to accommodate costs that these additional requests bring, as well as to maintain a beautiful and respectful place to care for your loved one. Since the “Direct Cremation” and “Direct Burial” are packages that include the Basic Service Fee, and have the above defined limitations, and should a family want to add additional services to the low-cost options we make available, please be advised that if you request additional services that would be more closely associated with a traditional type service (dressing, embalming, viewing, use of chapel, clergy to pray over the body, witness of burial or cremation at a specific time and place) then you are effectively changing from a “Package” based pricing option to an A la Carte pricing option, and we reserve the right to calculate fees accordingly.

Park View Cemetery & Funeral Home provides specialized pre-need and at-need planning arrangements from customized traditional services to simplified services such as direct cremation or direct burial; but also offer fully customized services of Cemetery, Funeral Home, Crematory, Flowers, and Monuments, all at one convenient location.

Individuals have expressed to us the sense of relief and serenity they have experienced having known or discovered their loved ones thoughtfully attended to and completed the task of pre-planning and pre-paying their funeral arrangement. Prearrangements ensure: 1) Your wishes are carried out; 2) Keeps your survivors from “emotionally over spending,” 3) keeps your survivors from having to gather legal authorizations from numerous survivors at the time of need; 4) It can lock in the price and keeps the cost of your arrangements protected against inflation; 5) Your money is fully protected and safe until we render services, at which time we are paid by the preneed insurance policy that has secured your preneed funds. ### **FINANCIAL TERMS**

AT-NEED: Payment for selected products and services, where a death has occurred, are due in full at the completion of the arrangement. Payment options are cash, money order, cashiers check, or Visa, MasterCard, American Express and Discover credit cards, or any debit card with a Visa/Master Card logo on it. Due to the high rate of returned checks, we no longer accept checks for at-need service arrangements.

If you are wanting to pay for the services with an insurance policy, you may do so, as long as the insurance policy is verifiable and is in force beyond the contestable period at the time of death of the insured; AND is assignable by the beneficiary to Park View Cemetery & Funeral Home, at the time of the arrangements; and is free of liens. We utilize a third party for this process. There are additional fees for the assignment of an insurance policy. The beneficiary must be known. Such policies are acceptable as a guarantee of payment of the balance due, as long as the policy is processed and accepted by our third-party processor. This in no way relieves the beneficiary or purchaser of his/her obligation to pay should the insurance company fail to honor the policy or assignment. Interest will be charged after 30 days beyond the initial service agreement date.

**FINANCING:** Park View offers financing through our partnership with Lending USA. This is a third-party lender. Additional fees and restrictions apply. Please ask one of our directors about this financing option. We can email you or text you a link and you can apply and receive an answer in minutes.

**PRE-NEED:** Park View accepts preneed funds that, by law, must be placed in a trust or insurance for prearranged funeral arrangements. We are obligated to deposit said funds within 30 days of collecting them. We utilize Great Western Insurance Company and California Master Trust - for the holding of preneed funds, until services are rendered. We want our clients to understand the process and reasoning for the strict guidelines used in protection of their deposited funds. Park View cannot gain access to these funds until the individual has passed away, and a death certificate with verification is provided to the trust or insurance institution. Your funds are protected and safely deposited as required by California State Law. **We also accept preneed policies from other funeral establishments and can often offer significant savings to your family by doing so.** If you have any comments, concerns, or questions, please call our office at 209-982-1611. ### **ESTATE CLAIMS**

It is the policy of Park View Cemetery & Funeral Home, that due to the average length of time, in excess of four (4) months (and up to 2 years) needed to obtain reimbursement of a claim against a decedents estate, estate claims are not considered an acceptable method of payment for service contracts. Estate claims may be filed by the next-of-kin or the person responsible for the service arrangements for reimbursement of funeral expenses.
