# FEDERAL BURIAL AND MEMORIAL BENEFITS FOR ELIGIBLE VETERANS

The United States recognizes the contributions of Veterans and extends to an Honorably Discharged Veteran a valuable debt of gratitude in the form of free burial benefits at a national cemetery. We have two National Cemetery offerings here in Michigan that are accepting prearranged and at-need families.

Established in 1981, Fort Custer National Cemetery is the first national cemetery established in Michigan. Fort Custer was named after General George Armstrong Custer, a native of the state of Michigan. Located midway between Chicago and Detroit, in Augusta, Michigan, the VA chose this beautiful historic site for its first National Cemetery in Michigan.

Established in 2005, Great Lakes National Cemetery is the second national cemetery built in Michigan. Amidst rolling hills and a picturesque lake setting, it is located just 45 miles northwest of Metro Detroit in Holly, Michigan.

We have reserved these hallowed grounds as a tribute to those who have honorably and dutifully served our country. The free burial benefits do much to defray costs at the time of death.

## WHO IS ELIGIBLE?

#### **Armed Forces**

All members of the Armed Forces and Veterans who met minimum active duty service requirements and were discharged in conditions other than dishonorable may be buried in a national cemetery.

#### **Reserve Members**

Reserve members of the Armed Forces who die while on training duty, active duty, or were eligible for retirement pay or were called to active duty and served the full term of service for which they were called, may also be eligible for burial.

#### **Next of Kin**

Spouses, minor children, and, in certain situations, unmarried adult children with disabilities, may also be eligible for burial.



# BENEFITS BRAVELY EARNED

#### **Burial Headstones and Markers**

Upon request, the VA will furnish an inscribed headstone or marker for the unmarked grave of an eligible veteran or family member at any national, state Veterans, tribal, or private cemetery. The VA will deliver a marker or headstone, at no cost, to any location in the world.

#### Secondary Markers for Medal of Honor Recipients

For Medal of Honor (MOH) recipients, the VA will provide a secondary marker or headstone.

#### **Family Members**

Spouses and dependent children are eligible for a government marker or headstone only if they are buried in a national or state Veterans cemetery.

#### **Memorial Markers**

VA provides memorial headstones and markers for placement in a national cemetery, a Veterans cemetery owned by a state, tribal, local or private cemetery with "IN MEMORY OF" as the first line of inscription for those whose remains are unavailable for burial.

#### Medallion in lieu of government headstone or marker for private cemeteries

For eligible decedents who served in the U.S. Armed Forces on or after April 6, 1917, and are eligible for VA memorialization benefits (or would have been but for date of death), VA is authorized to provide a medallion instead of a marker or headstone if the grave is in a private cemetery and already marked with a privately-purchased headstone or marker.

#### Presidential Memorial Certificates (PMCs):

PMCs are issued to honor the memory of deceased persons whom the VA finds eligible for burial in a national cemetery.

#### **Burial Flags**

The VA will furnish a U.S. burial flag to recognize eligible deceased Veterans.



#### **Reimbursement of Burial Expenses**

The VA will cover up to \$2,000 if the Veteran's death is service-connected. In these cases, the person who covered the Veteran's burial expenses can claim reimbursement from VA. Depending on the situation, the VA may pay the cost of transporting the remains of a Veteran whose death was service-related to the nearest national cemetery with available gravesites. There is no time limit for filing reimbursement claims in service-connected death cases.

#### **Burial Allowance**

The VA will pay a funeral and burial allowance from \$300 to \$2000, depending on whether the death was service-related and other factors.

#### Plot Allowance

VA will pay a plot allowance of up to \$762 when a Veteran is buried in a cemetery not under U.S. government jurisdiction if:

- The Veteran was discharged from active duty because of disability incurred or aggravated in the line of duty;
- the Veteran was receiving compensation or pension or would have been if the Veteran was not receiving military retirement pay;
- or the Veteran died in a VA facility.

The plot allowance may be paid to the state for a cost of a plot or interment in a state-owned cemetery solely reserved for Veteran burials if the Veteran is buried without charge. Burial expenses paid by the deceased's employer or a state agency will not be reimbursed.

Veterans Cemeteries Administered by Other Agencies: The Department of the Army administers Arlington National Cemetery and other Army installation cemeteries. Eligibility for burial at an Army administered installation cemetery is generally more restrictive than at VA national cemeteries.

#### Valuable Benefits

## ARLINGTON NATIONAL CEMETERY

#### **Establishing Eligibility**

Arlington National Cemetery's eligibility requirements for burial and inurnment are different from other national cemeteries that are maintained by the Department of Veterans Affairs. Eligibility for in-ground burial at Arlington National Cemetery is the most stringent of all U.S. national cemeteries. However, most veterans who have at least one day of active service (other than for training) and an honorable discharge are eligible for above-ground inurnment. Eligibility is determined at the time of need.
