## GSA/USBC Tournament Rules

- 1. Eligibility:** All participants must be Greater Sacramento Area USBC members.
- 2. Lane Condition:** Typical House Shot pattern and fresh oil after each squad.
- 3. Average:** Entrants will use their highest 2024-25 fall/winter season average of at least 21 games. If none, entrants must provide the league standing sheet from the current season of at least 21 games. If neither of the above averages is available, then the entrant will be assigned an average of 230.  
Entrants are responsible for verifying their own average at the time the entry form is submitted. If the tournament committee finds that the reported average is incorrect, then a corrected average will be used, and the entrant may be disqualified. Entrants are responsible to report and comply with USBC Rule 319.  
**Rule 319C states:** **The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. GSA Tournament Directors have the authority to do this average adjustment based on past GSA tournament performances.**
- 4. Handicap:** Handicap will be 90% of difference from 230 per bowler within each of the categories delineated on the front of the entry form.
- 5. Format:** Bowlers will bowl 3 games on one pair of lanes for Team Event and 6 games on one pair of lanes for Singles and Doubles. You must be ready to bowl when it's your turn.  
**Note:** Bowlers may bowl multiple Team squads and cash multiple times as long as at least two new team members are included. Bowlers may bowl in Singles & Doubles multiple times with different Doubles partners. Bowlers may cash with each different Doubles partner, but they can only cash ONCE in Singles. A bowler's first series in each event will be used for All Events.
- 6. Awards:** A ratio of at least 1:6 will be used for team, singles & doubles. 1:10 for all-events.
- 7. Entry Fee Breakdown:** Singles, Doubles & Team \$40.00 per event. All Events \$15.00 Lineage \$11.50, Expenses \$3.50, Prize Fund \$25.00 per person, per event.
- 8. Other Rules:**
  - Conduct:** Good sportsmanship is required by all participants. Any unsporting behavior will be addressed by the tournament committee and may result in a warning or disqualification.
  - Dress code:** All bowlers must wear suitable attire. All clothing must be neat, clean and in good condition. No inappropriate advertisements will be allowed on any attire or equipment. Jeans, slacks, walking shorts, Capri pants, mock shirts, skirts and hats are permitted. No tank tops, halter tops, spaghetti straps, sweats, gym shorts, or cut-offs of any kind allowed.
  - General Provisions:** Only participants and tournament personnel are allowed in the settee area. No food or drink is allowed in the settee area. No powdery product (e.g. Easy Slide, baby powder) may be applied to bowling shoes at any time. No audio devices are permitted in the settee area. Compliance with the dress code (see above) will be monitored by the tournament committee.
  - Protests/Appeals:** Any protest or appeal must be received by the Greater Sacramento Area USBC office within 72 hours of the infraction.
  - USBC Rules:** USBC rules will govern any aspect of tournament played that is not specifically addressed in these rules.
