# Tournament Rules

1. **Eligibility:** All participants must have a current 2025-2026 GSA-USBC membership card.
2. **Entering Average:** Entrants will use Standard Composite Average for the 2025-2026 season. If 2025-2026 avg is not available, then GSA will refer to the 2024-2025 Standard Composite Average. If neither, bowler will be assigned a 230 entering average.
3. **Average Verification:** GSA will verify all bowlers averages upon entry. If league secretaires have not submitted the 2025-2026 league averages we will refer to the 2024-2025 Standard Composite Average. If the submitted average is lower than the average verified by the GSA officials, then the bowler will use the average verified by GSA officials.
4. **Handicap:** Shall be 90% of the difference of combined entering average and 460.
5. **Format:** Teams will bowl four (4) games on one pair of lanes. Each team will throw out their lowest 2 game set. The six games remaining will form the team series score.
6. **Multiple Entries:** Not at this tournament.
7. **Awards:** Ratio of at least 1:6. All awards fees returned 100%. **Fees per bowler:** \$40.00, Lineage \$16.00, Prize Fund \$21.50, Expenses \$2.50
8. **Protests/Appeals:** Protests and appeals must be made in writing stating grounds for the protest or appeal within 72 hours of the infraction. (Rule 329a)
9. **USBC Rules:** USBC rules will govern any aspect of tournament played that is not specifically addressed in these rules.
10. **Entries:** Walk-in entries may be allowed depending on lane availability, fees are \$100.00 per team.
11. A **\$25.00 service fee** will be charged for all returned checks.
