# CONTRACT TO IDEMNIFY

For and in consideration of Vaughn's Cowtown Bail Bonds, hereinafter referred to as VCBB, securing the release (from jail) of \_\_\_\_\_, hereinafter referred to as Bonded Person have posted a bond in the amount of \_\_\_\_\_. I, \_\_\_\_\_, hereinafter referred to as indemnitor, agree to pay VCBB the following:

If Bonded person is returned to court before ten (10) days of missing scheduled court date, there will be no additional fees for Indemnitor to pay VCBB.

After ten (10) days, if Bonded Person is returned to court within 180 days for a misdemeanor, and 270 days for a felony, Indemnitor will pay VCBB the court cost owed plus interest each day missed after the ten (10) days. Court Cost average is \$466.00

\_\_\_\_\_ Indemnitor Initials

If Bonded Person is not returned to court within 180 days (Misdemeanor) of missing scheduled court date and 270 days (Felony), Indemnitor understands they are responsible for the full amount of bond and will pay 100 percent (100%) of total bond amount plus court cost (Avg \$350.00) to VCBB and all fees connected to fugitive apprehension.

**A bond-forfeiture occurs when it appears to the judge of the court where Bonded Person's case is docketed that the Bonded Person did not appear in court and the judge so designates, notes, writes or expresses the same on the court's docket.**

Indemnitor further agrees to assume all liability for any balance due on account when bond is posted.

Indemnitor understands that if further explanation is necessary as to the meaning of a bond forfeiture or writ forfeiture, it will be explained by VCBB before Indemnitor should sign this contract.
