The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL SERVICES AND STAFF \$2000.00

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filling of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING \$925.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

CREMATION SERVICE

DIRECT CREMATION \$1500.00 - \$7500.00

Our charge for a direct cremation includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations. *****Does NOT include Urn, Certified Copied of Death, Clergy, Musician, Newspaper Notice, Flowers and Programs.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container.

A. Direct Cremation with container provided by the purchaser (Container must be leak-restraint and approved by crematory)	\$1,500.00
B. Direct Cremation with fiberboard container (Provided by the crematory)	\$1,875.00
C. Direct Cremation with the casket of the purchaser's choice (Plus the cost of the casket)	\$1,500.00
D. Any decedent that passed at home that is NOT under Hospice care or referred to the medical examiner will incur a charge of \$50.00 to have the medical examiner sign Medical Examiner's Authorization.
