- 1) Call meeting to order;
- 2) Public Comment: In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda. Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda. Additionally, individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item.

- 9) Conduct annual review of investment policy and investment strategies and adopt resolution confirming;
- 10) Review Resolution Regarding Public Participation at Open Meetings and make changes as appropriate, *if needed*;

11) Discuss agenda items, time, and date for next meeting;

12) Adjournment.
