CALL TO ORDER

The meeting was called to order at 6:30 p.m. by Mayor Elizabeth Armstrong. The meeting was held at The Loose Senior Center located at 707 North Bridge Street, Linden, Michigan 48451.

(A) Presentation by: Genesee County Department of Senior Services Lynn Radzilowski, Senior Services Director presented on the Department and discussed millage details; Loose progress and positive changes; numbers served; programs offered; and referenced information packet provided to Council.

Grice addressed comment regarding culvert, brief discussion with resident commentor. Glass and Grice acknowledged comment about the tree; and speeding and signage and will discuss with Police Chief Sutter. Kanyak addressed comment about the availability and posting methods of city meeting schedule. Glass provided an update on the Loose Advisory Committee; addressed trash and Sonitrol comments; event application details for annual event; and reasoning for temporary hold on donations.
