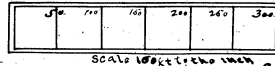

Village of North Linden, Being

a replat of Blocks 8, 9, 10, 11, 12, 13, 14, 16, 17, 18 and west part of Block 15 in the Village of North Linden as platted by Mellen Davenport January 31, 1867 and described as beginning at a point from which the quarter part of West line of Section No. Twenty in Township No. 5 North of Range No. 6 East, Securus County, Michigan, bears south distant one thousand and twenty eight feet, thence North along Section line thirteen hundred and twenty five feet to the West line of the Detroit and Milwaukee Railroad land - thence South sixty two degrees east fifteen hundred and one feet to the West line of Main Street - thence South sixty feet to the West line of First Street - thence West one hundred and thirty feet, thence South five hundred and eighty feet, thence West eleven hundred and eighty feet to the place of beginning - Being situated on West half of North east quarter of Section No. Twenty, Township No. five North of Range No. Six East, Securus County, Michigan.



Dedication

Know all men by these presents that the land laid out and platted on the annexed Map is owned by Catho. Duthuland, of the City of Ann Arbor, Asa S. Whitehead, of the Town of Argoshtown, Securus County and George J. Gorman of the Town of Denton, same County, all of the State of Michigan. That the said Map or plat is now executed by the said Catho. Duthuland, Asa S. Whitehead and George J. Gorman as proprietors and Stephen Mathewson as Surveyor, in accordance with the provisions of an Act to provide for recording Town plats and vacating the same in certain cases, and the Acts amendatory thereto, and for the purpose of being recorded as "Map of a part of the Village of North Linden" - The size of the lots and the width of the Streets are given on said Map in feet. 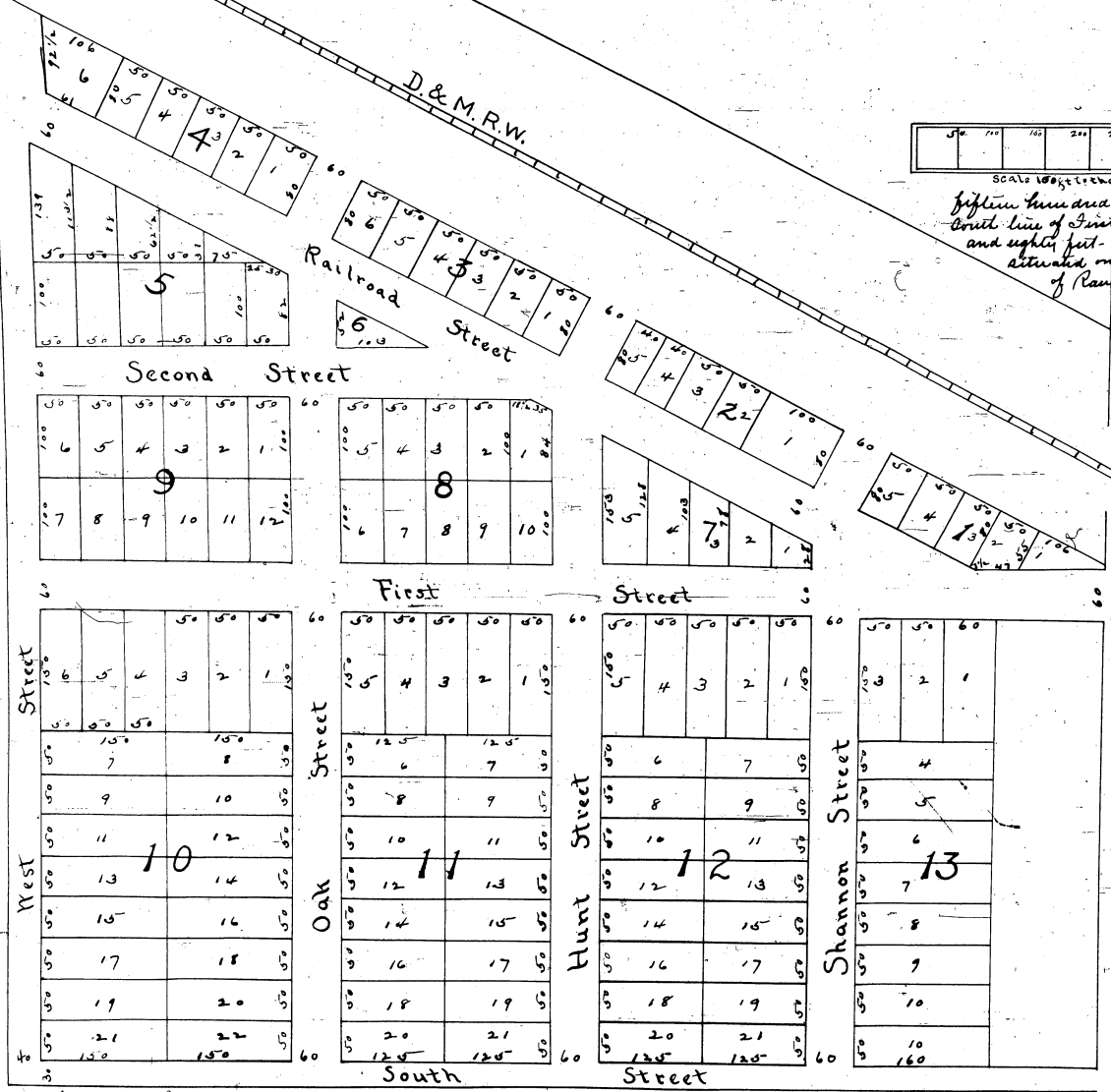
