We also saw additional Downtown Parking Signage installed to clarify parking options for residents & visitors.

DECODING YOUR ANNUAL NOTICE OF ASSESSMENT...



It's that time of year again. In mid-February, residents will receive a Notice of Assessment in the mail. Please note, this is not a tax bill! This notice will present the Assessed & Taxable Values to be used for the 2026 tax year, as well as the prior year's values. Residential parcels will also indicate your Principal Residence Exemption (PRE) percentage. The notice will also include the Board of Review meeting information, as well as the process for appealing an assessment. A property owner who makes an appeal must provide documented evidence as to why the assessment is inaccurate or incorrect. Evidence may include an appraisal, a list of sales in your neighborhood that are similar to your home, or pictures of damage or deterioration that may exist, among other things. Here are some tips to help to decode your Assessment Notice:

- Assessed Value: approx. 50% of your property's cash value (market value)
- Taxable Value: used to calculate your property taxes & is the lesser of Capped Value or Assessed Value.
- Capped Value: the value you pay tax on each year is capped at the prior year's Taxable Value times the Consumers Price Index (CPI).

A Taxable Value "uncaps" the year following a transfer of ownership. It will be uncapped & equal to the Assessed Value for that year. The increase of Assessed or Taxable Value shown on your notice does not mean you will pay that much more in taxes. There is a box on the notice that shows the approx. amount your annual tax obligation will increase/decrease. Please review this information to ensure its accuracy. INFRASTRUCTURE UPDATE

Lindenwood Neighborhood Improvement Project

The Lindenwood Project is considered complete at this time. City inspectors and staff will continue to monitor landscape repairs for settling and to ensure appropriate turf establishment in the spring.

West Rolston Road Reconstruction Project

The West Rolston Road Project has been completed and is fully open to travel.

Safe Routes to School Project

The Safe Routes to School Project along Stan Eaton Drive and Hyatt Lane started in late October. The intent of the project is to provide safe pedestrian connections to Hyatt Elementary from W. Broad Street and S. Bridge Street. Prior to the onset of cold weather, the contractor was able to install the new asphalt pathway along Stan Eaton between S. Bridge Street and Hyatt Elementary School. They also began working on the installation of new sidewalks along the east and west sides of Hyatt Lane to make connections to W. Broad Street. Unfortunately, early winter weather brought progress to a halt in the first week of December. The contractor is expected to return in early spring to complete the project. The new sidewalks and pathways are expected to be opened once construction is completed and the areas are relandscaped.

The Linden Mill Rehabilitation Project

Work continues on the Linden Mill Rehabilitation Project. Contractors are currently working on exposing and rehabilitating the original stone foundations on the east and south sides of the building. This portion of the project is proving to be a slow and tedious process as structural engineers carefully examine, design, and direct the appropriate repairs. This activity is expected to continue for many weeks as the contractor works to slowly expose and stabilize small sections of the foundation. This procedure is critically important to ensure the long-term structural stability of the building before proceeding with other rehabilitation efforts.

SAFE SNOW REMOVAL REMINDERS

The DPW would like to share tips to make snow removal easier & safer:

- No on-street parking (November 1 - March 31 from 2:30 a.m. to 6:00 a.m.)
- Please remove trash cans from the roadside.
- Ensure your mailbox post is sturdy, straight & securely attached! Wet, heavy snow weighs hundreds of pounds when rolling out of a plow & the force can snap a compromised post or knock a poorly attached box from its mount. Make sure your mailbox is the proper distance behind the curb to prevent damage from plows. Helpful installation info can be found on the USPS website: <https://www.usps.com/manage/mailboxes.htm>
- Be strategic with snow removal efforts to reduce the amount of snow rolled into your driveway. The depiction below provides helpful advice on how to reduce or avoid repeating your snow removal efforts.
- It's unsafe & illegal to push, throw, shovel, plow or snow blow snow into the roadway.
- Keep children from playing in snow piles near the roadway.

To ensure safety & walkability, City Ordinance requires clearing sidewalks (in front of & adjacent to) from snow & ice to facilitate pedestrian use. It is asked to be cleared within 24 hours after it has fallen or accumulated (\$151.26). Thank you for your safe, snow removal efforts!

Avoid the "Second Shovel"

People can play a part in ensuring the ends of their driveways remain clear of snow even after their local snowplow comes through. Shoveling a "corner" of the right-of-way free of snow in the area several feet before the driveway will help keep that same snow from being pushed into the driveway in an icy, heavy pile. Clearing an area large enough to hold the snow coming off the plow may help reduce the "second shovel."
