Dear Applicant,

This application is to be used by any operator of a Mobile Food and Beverage Vehicle who wishes to obtain a license to operate within the City of Linden. The operation of a Mobile Food and Beverage Vehicle must comply with the requirements of Chapter 118 of the Linden Code of Ordinances. Licenses are issued for one year and must be renewed on an annual basis.

When applying for a Mobile Food and Beverage License with the City of Linden, please have the following when you return your application to the Clerk's office.

- Proof of General Liability Insurance
- Copy of the State license for food service under Michigan Public Act 92 of 2000 (Food Law)
- Application:
 - Photos of Food Trucks

The City of Linden Mobile Food and Beverage Vehicle Vending Application must be filled out by each applicant and returned to the City Clerk's Office. Once all the information required is received the application process will begin. The application cannot process until all documents are received.

Once your application is received, we will proceed with the review. If approved, you will be contacted by a representative from the City Clerk's office that your license is ready for issuance. Payments of the \$50 license fee is due before the license will be issued. Please note that this process can take up to 10 business days.
